Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its San Juan 30-4 # 48 Pictured Cliffs formation well under the provisions of New Mexico Oil Conservation Division, East Blanco Pictured Cliffs Pool rules. 72400

This well is located in the SE/4 of Section 17-T30N-R4W, Rio Arriba County, New Mexico and is dedicated to a spacing unit consisting of the SE/4 of Section 17, in the East Blanco Pictured Cliffs gas pool.

This well is located closer than 660' from the eastern proration unit boundary by 550'. This well is within the boundaries of the San Juan 30-4 Unit. This location is being drilled as a horizontal well bore and is situated so that the longest lateral can be accessed. This additional length is required to provide for the potential for the production of the most reserves and the best possible economics for this well.

Energen Resources Corporation is the owner of all offsetting spacing units, therefore no affected owner letter is being sent out and no waivers are required..
