

FOR APPROVAL OF AN UNORTHODOX
LOCATION, LEA COUNTY, NEW MEXICO

A P P L I C A T I O N

COMES NOW ADOBE OIL & GAS CORPORATION and applies to the New Mexico Oil Conservation Division for approval of its unorthodox well location for its Gray "35" No. 1 well located 660 feet from the South line and 1650 feet from the West line of Section 35. T14S, R33E, Lea County, New Mexico and in support thereof would show:


1. Applicant is the owner of the right to drill on the S/2 of Section 35, T14S, R33E, Lea County, New Mexico.
2. Applicant commenced a Devonian well located 660 feet from the South line and 1650 feet from the West line of said Section 35 projected to a total depth of 13,500 feet.
3. Applicant drilled to a T. D. of 13,062 and has subsequently plugged back the well to a total depth of 12,861 and completed the subject well as a Morrow producer with perforations between 12,382 feet and 12,390 feet.
4. Applicant has obtained a voluntary agreement among the working interests owners in the S/2 of said section and proposes to dedicate the S/2 of said section to this Morrow well.
5. Approval of this application will not impair correlative rights and will prevent waste.

WHEREFORE, APPLICANT RESPECTFULLY REQUESTS THAT THIS application be set for hearing before the Divisions Examiner and that after notice and hearing, the order to be entered authorizing the unorthodox well location.
