Reference is made to your application dated November 1, 1994, for a non-standard Bone Spring oil well location for your existing Federal "BN" Well No. 1 (API No. 30-015-23498), which was drilled in 1980 to a total depth of 11,752 feet and was completed in the Happy Valley-Morrow Gas Pool at a previously approved non-standard gas well location (Division Administrative Order NSL-1268, dated October 6, 1980) 1592 feet from the North line and 444 feet from the East line (Unit H) of Section 17, Township 22 South, Range 26 East, NMPM, Eddy County, New Mexico.

It is my understanding that said well will be recompleted up-hole to test the Bone Spring formation, which pursuant to Division General Rule 104.B(1)(b), is also unorthodox.
