

This is a request for administrative approval for a non-standard gas well location in the Otero Chacra pool.

Burlington Resources intends to recomplete the Reid A SRC #1M (formerly the Reid A #1M), a Blanco Mesaverde-Basin Dakota well, add the Otero Chacra, and downhole commingle the three. Order NSL-1425 was issued for the Blanco Mesaverde and Basin Dakota.

Production from the Otero Chacra is included in a 155.50 acre gas spacing unit comprising of the southeast quarter (SE/4) of Section 13. Production from the Blanco Mesaverde is included in a 320 acre gas spacing unit comprising of the east half (E/2) of Section 13 and is to be dedicated to the Reid A SRC #1 (30-045-12043) located at 1120'FNL, 970'FEL in Section 13. Production from the Basin Dakota is included in a 320 acre gas spacing unit comprising of the east half (E/2) of Section 13 and is to be dedicated to the Reid A SRC #1 (30-045-12043) located at 1120'FNL, 970'FEL in Section 13.
