

Please consider this letter as a request for the above referenced well location. This well was originally permitted as a Basin Dakota well. It has been determined that the well will be a West Lindreth Gallup/Dakota extension. The well as staked is located near (between) two existing natural gas pipelines. It would be impossible to move the location to conform with the spacing requirement for this formation without rerouting the pipelines. Attached is a topo map and plat showing the well placement in relationship to the pipelines and the offsetting operators.

The offset operators have been notified of this proposal as of this date.




