As operator of the Northeast Blanco Unit, we are requesting administrative approval of a non-standard well location to be completed in the Mesaverde Formation.

We intend to drill the Northeast Blanco Unit Well No. 76, a development well, located 1850' F/NL - 500' F/WL, E-34-31N-7W, San Juan County, New Mexico.

This location is on Federal Royalty, and under the surface control of the United States Bureau of Reclamation and Bureau of Land Management, who have witnessed this proposed well site. It is located on a bluff immediately above Dick Earl Canyon to the East. It is the most logical well site agreeable to all parties.

All offset acreage is within the bounds of the Northeast Blanco Unit and will not present a drainage problem to any offset operator.






