Letters have been sent to all offset owners or operators.

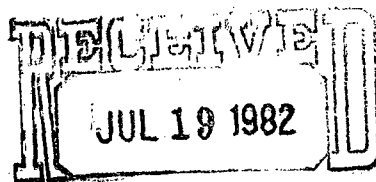

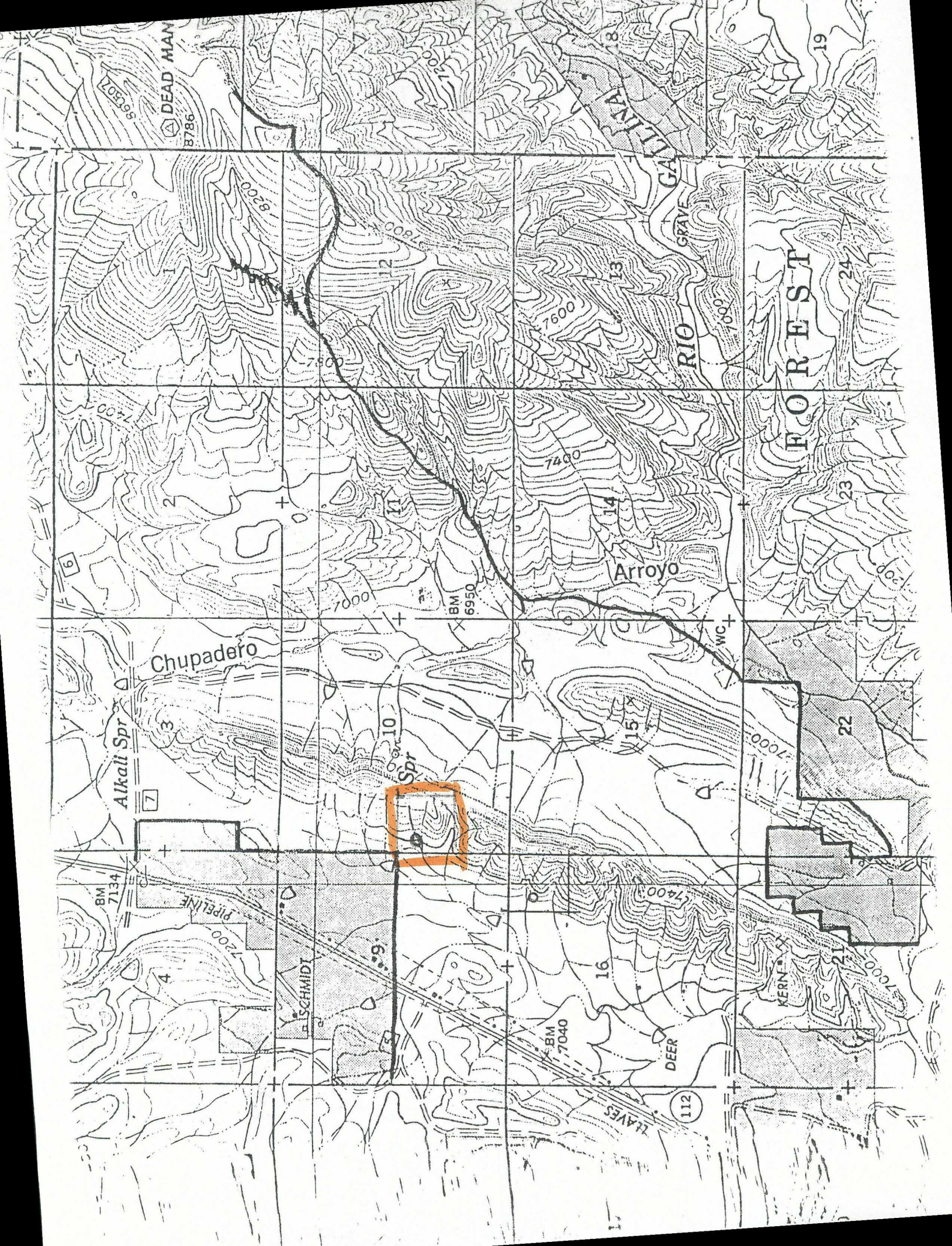

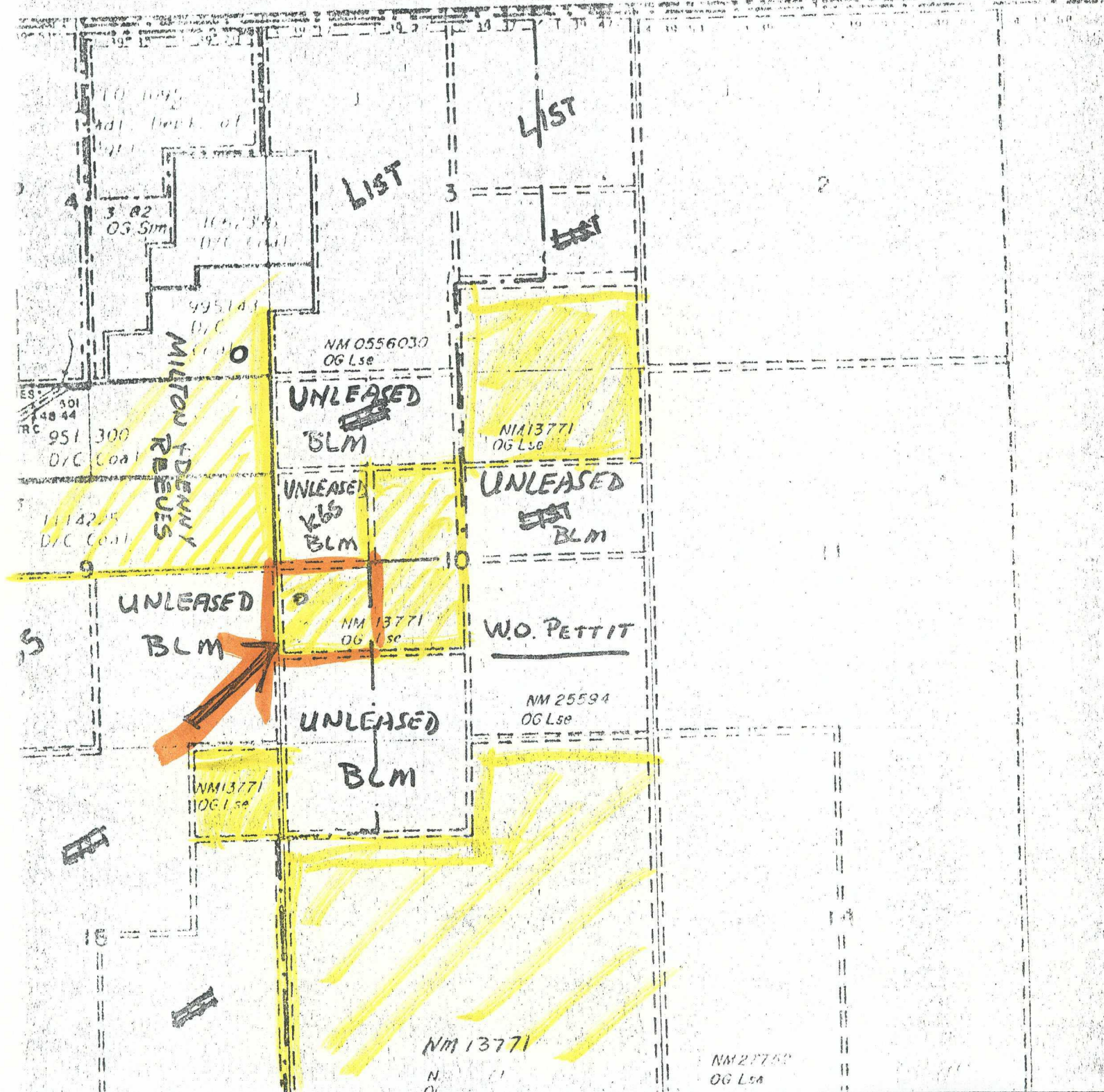

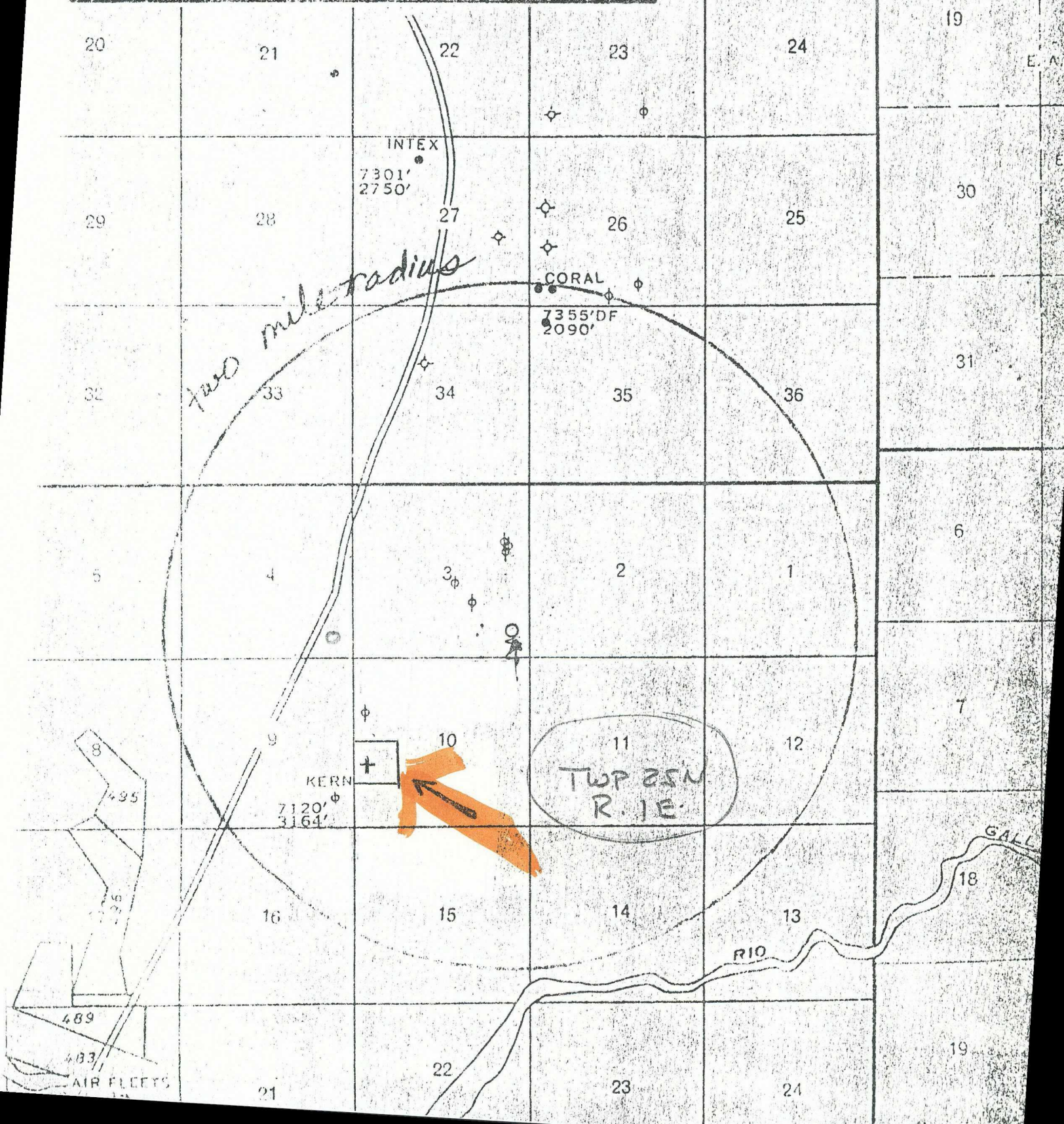

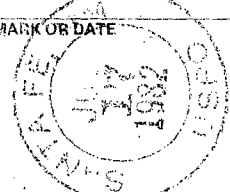
EXHIBIT "F" Radius Map of Area
