

Dear Mr. Stammets:

McClellan Oil Corporation would appreciate an administrative approval for a proposed unorthodox Abo gas well location, as provided for under NMOCD Rule 104 F.

The Coyote Federal No. 4-Y is staked in its present location due to hole problems on the Coyote Federal No. 4 which resulted in an abandoned hole, which necessitated moving the Coyote Federal No. 4-Y to its present location. We were unable to move the location south due to erosional and drainage problems and an existing gas pipeline as was the case with the Coyote Federal No. 4 which was granted approval for an unorthodox location under Administrative order NSL-1570. Thus, we are requesting administrative approval for this location for topographical reasons; a gas pipeline and an abandoned hole to the south.

The enclosed lease map shows the offset operators who have been sent requests for waivers stating that they have no objection to the above captioned location.

We will appreciate your expeditious approval and issuance of the administrative order.



DOTTED LINES REPRESENT 5 FOOT CONTOURS




