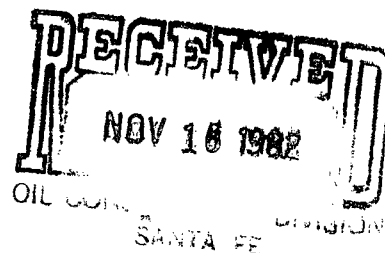

Gentlemen:

We are currently in the process of filing a C-101 (Application for Permit to drill) and C-102 (Proration Unit Plat) with the New Mexico Oil Conservation Division District Office in Hobbs, New Mexico for permit to drill a second Jalmat Gas Well as an infill well to the same producing interval on an existing 80-acre non-standard proration unit comprised of the NE/4 SE/4 and SE/4 NE/4 of Section 36, T-24-S, R-36-E, Lea County, New Mexico. The subject 80-acre non-standard proration unit is currently dedicated to the Doyle Hartman Langlie "A" State No. 2 well located in H-36-24-36. The proposed new well will be drilled at an unorthodox Jalmat Gas location consisting of 1980' FSL and 330' FEL of Section 36, T-24-S, R-36-E.

Therefore, we hereby file for administrative approval to drill the proposed well at the unorthodox location of 1980' FSL and 330' FEL of Section 36 and to simultaneously dedicate the 80-acre non-standard proration unit comprised of the SE/4 NE/4 and NE/4 SE/4 of Section 36, T-24-S, R-36-E to both the existing Jalmat Gas Well (Langlie "A" State No. 2 located in H-36-24-36) and to our proposed new well (Langlie "A" State No. 3 located in I-36-24-36).

Furthermore, if the proposed well is completed as a commercial producer, and in compliance with the Natural Gas Policy of 1978, an application will also be submitted to the New Mexico Oil Conservation Division to obtain administrative approval for the well as a Section 103 infill well located on a previously existing proration unit.

As to our application for an unorthodox location, the subject request is necessitated by a combination of (1) the narrow shape of the existing 80-acre Jalmat gas proration unit, (2) the current existence of wellbores at the two standard Jalmat gas locations, and (3) the presence of other production equipment, flowlines, pipelines, and powerlines at critical points on the 80-acre proration unit.

Three copies of a plat showing the location of the original well on the existing 80-acre proration unit plus the location of the proposed new well are enclosed.



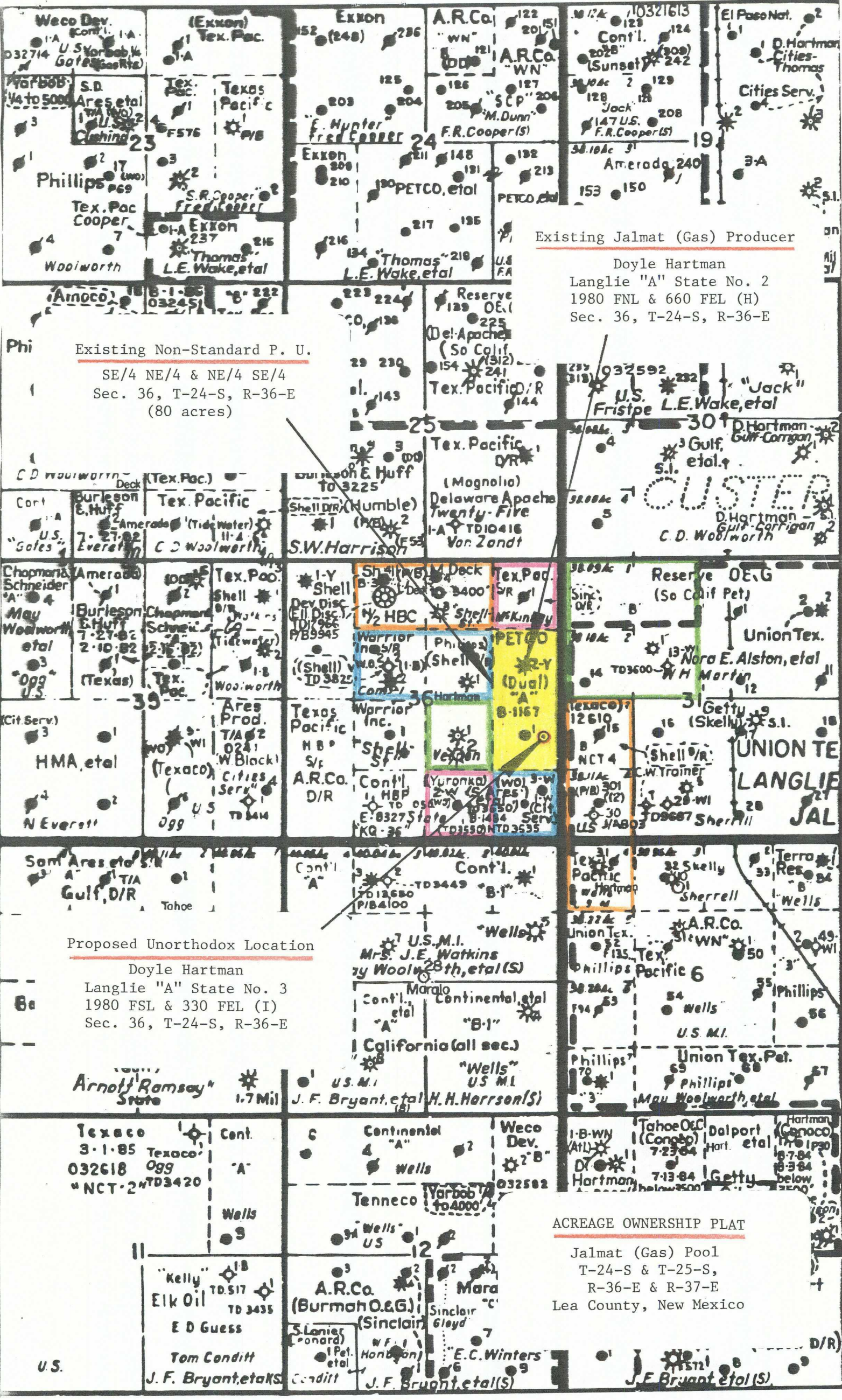
