
Gentlemen:

Robert N. Enfield, whose address is P. O. Box 2431, Santa Fe, New Mexico 87501, respectfully requests administrative approval to amend his application of an unorthodox location for well No. 1 Douglas from 1650 feet from the south and east line to 1650 feet from the east line and 1700 feet from the south line of Section 7, T-19-S, R-27-E, Eddy County, New Mexico. It was necessary to move the location 50' north in order to comply with the Bureau of Reclamation's requirement of no well being drilled below 3270.4'.

All of the reasons stated in my original application certainly apply to this amended application.

For your information I have advised both Yates Petroleum and Southland Royalty, being the only offsetting operators, and they have given me their verbal approval for this change. All other parties, being Robert N. Enfield, Rio Pecos Corporation and Coquina Oil Corporation are participants in this proposed well and they agree to the 50' change.

Therefore it would be appreciated if you could give approval as soon as possible as we would like to commence work on this well.



Gentlemen:

Robert N. Enfield, whose address is P. O. Box 2431, Santa Fe, New Mexico 87501, respectfully requests administrative approval of an unorthodox location, because of topographical conditions, for well No. 1 Douglas to be located 1650 feet from the south line and east lines of Section 7, T-19-S, R-27-E, Eddy County, New Mexico. The well is a proposed 10,200-foot Morrow test on a fee lease with the south half of Section 7 to be dedicated to the well.

Exhibit "A", attached, is a portion of a topographic map (Lake McMillan North Quadrangle) showing topography in the area, a regular lease location, the proposed unorthodox location, the spacing unit, and the proposed access road. The proposed well is in the flood plain of the Pecos River. The land surface slopes gently toward Lake McMillan. Top soil at the well site is a deep loamy soil from recent mixed alluvium.

Reasons for the proposed unorthodox location are as follows:

1. A regular location 1650 feet from the south line and 1980 feet from the east line of Section 7, as shown on Exhibit "A", would be very close to one of the flood plain drainages.
2. The proposed location would be farther from the West Channel of the Pecos River.
3. The ground elevation at the proposed location is higher than at the regular location so the proposed well site would be inundated less during a flood.

To minimize obstruction of water-flow in drainages crossed by the access road, the top of the road in the drainages will be constructed level with the bottom of the drainages.

Exhibit "B", attached, is a plat showing ownership of leases offsetting the spacing unit for the proposed well and the locations of nearby wells.

Letters asking for waiver of objection, together with a copy of this application, were sent to all offsetting operators by certified mail this date.



 EDDY COUNTY, N.M. SCALE: 1" = 2000'




