

In the Dakota formation the location of this well is orthodox. However, Getty wishes to plug the Dakota formation back and recomplete this well in the Devil's Fork Gallup formation. The proposed recompletion will, therefore, place the well location closer than 330 feet from the quarter-quarter section line (See attached C-102). The proposed recompletion will also change the well name to Farming "E" #4 in the Gallup formation.

Offset operators were notified of our Application for an Unorthodox well location by certified mail on December 3, 1982.



