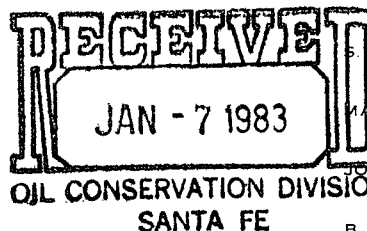

Yates Petroleum Corporation is proposing to drill the above referenced well. We are requesting administrative approval for this unorthodox location. The reason for moving this well is due to a draw which the original location fell in. Due to topography, the BLM would not permit us to drill this location of 660' FNL and 660' FWL.

Enclosed is a topographical map showing the draw and a lease map. Offsetting lease acreage is owned by Husky Oil Co., R. B. Cobie and R. Ibied, who have been notified by certified mail of our intentions.

Formations we expect to drill through are: San Andres, Glorieta, Fullerton, Abo. The well will be an Abo test.

Thank you for your help in this matter.

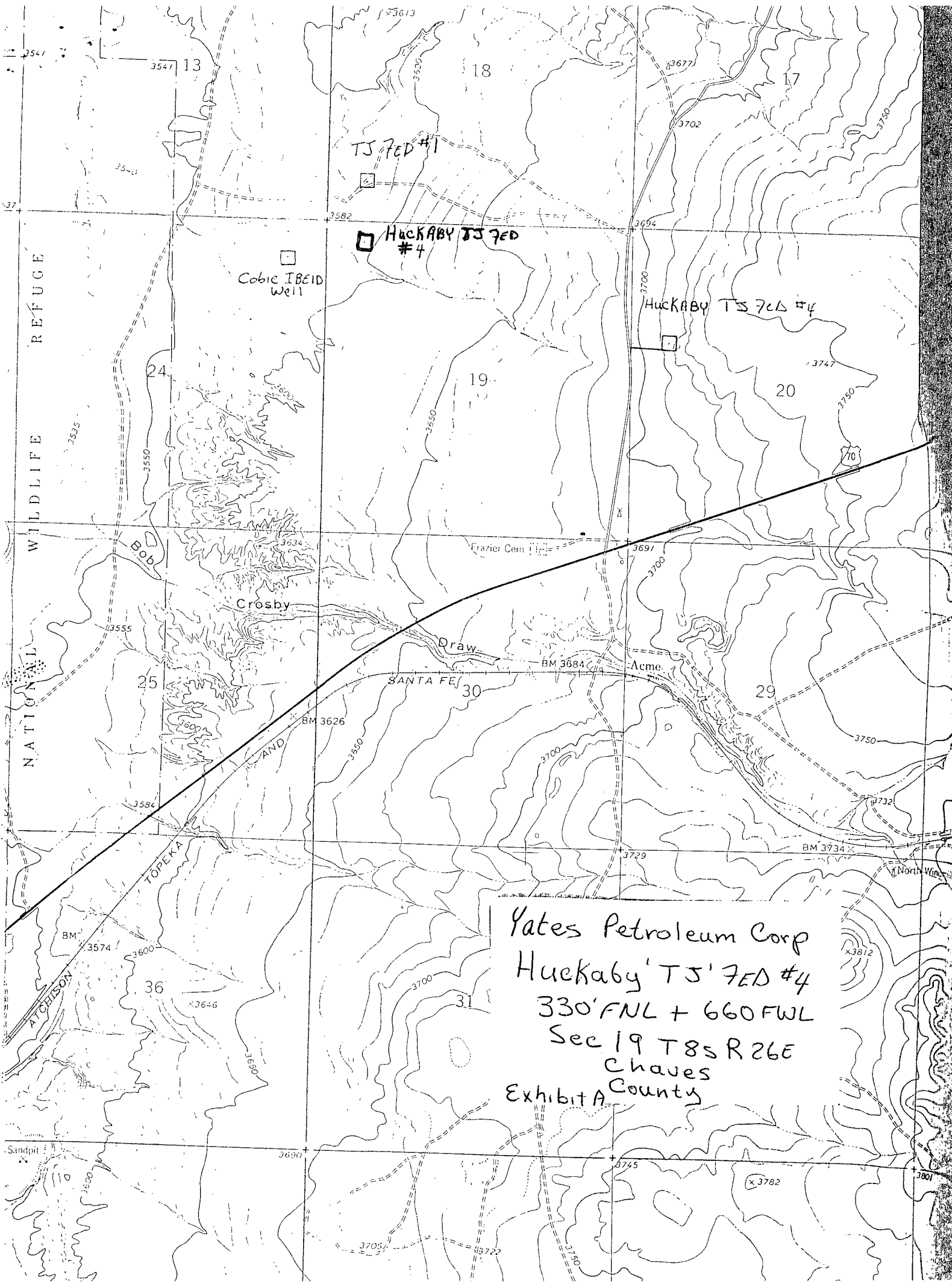
