

The attached waterflood orders indicate that administrative approval may be obtained for necessary unorthodox locations.

The proposed well #104 is offset by an injection well, HSU #87 and producers #23, #85, and #56. This well #104 is located in an area we believe to be undrained by the existing producing wells.

The acreage surrounding the Unit "C" is unitized which would protect the correlative rights. We believe this well will be in the best interests of conservation.

Also attached are other data and information required by the Commission under Rule 104.






