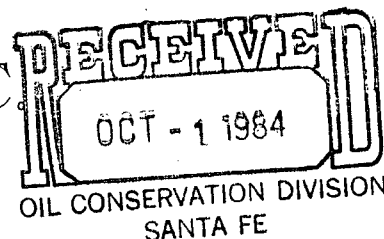

Gentlemen:

Joel B. Burr, Jr. requests an unorthodox location for his No.1 Foothills "A" located 1185' FSL & 690 FWL 20-30N-21W, San Juan Co., NM. The well was originally drilled to the Pictured Cliffs, but is now completed in the Fruitland formation. A non-standard location was approved for the Pictured Cliffs as NSL-1693. This application requests approval of non-standard spacing for the Fruitland. The request is based on topographic restrictions.

The topographic restrictions are a very steep hill to the east and an existing well with production equipment and pipelines to the south. A map showing these features is attached.

All offset operators have been notified by certified mail. A map showing ownership of offset 160's and all wells completed there-on is attached.
