

Gentlemen:

V-F Petroleum Inc. respectfully requests final administrative approval of the subject non-standard location to be drilled as a replacement well for the State 32#2 which, because of an uncontrollable water flow, was plugged and abandoned prior to reaching total depth. The State 32#2 was being drilled as a replacement well for the State 32#1. Verbal approval for this request was given by Joe Ramey on September 15, 1983, and the required waivers were sent to the NMOGC on November 7, 1983.

It is not feasible to drill an orthodox location within 200' from the center of the quarter-quarter section because of the presence of a major lease road and a water well and stock watering pond as shown on the attached plat. The subject location is approximately 600' from the water well, 570' from the P & A #2, and 400' down slope from the stock pond.


