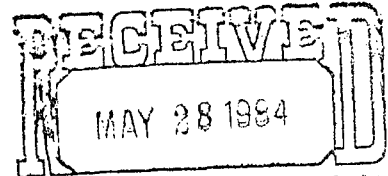

Dear Mr. Ramey:

The purpose of this letter is to request administrative approval without notice and hearing of unorthodox well locations within a secondary recovery project. The well locations for which administrative approval are sought are the M. Dodd B No. 41 located 2615 feet FNL and 330 feet FEL in Section 14, the M. Dodd B No. 42 located 2615 feet FNL and 1345 feet FEL in Section 14, and the M. Dodd B No. 43 located 2565 feet FSL 2465 feet FEL in Section 14, all in Township 17 South, Range 29 East, Eddy County, New Mexico. The wells will be completed in the Grayburg San Andres formation in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool. The wells will permit and continue to effect an efficient production and injection pattern within the secondary recovery project and are necessary for adequate drainage. Note that these locations are not closer than 330 feet to an outer boundary of the lease nor closer than 10 feet to any quarter quarter section line.

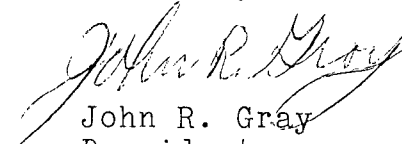

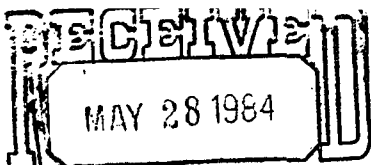

Phillips Oil Company has been notified of this application as it pertains to the M. Dodd B No. 41 by certified mail and has been requested to notify you if they have no objections. Please note that the M. Dodd B No. 42 is located in the SW1/4NE1/4 of 14-17-29 and the M. Dodd B No. 43 well is located in the NW1/4SE1/4 of 14-17-29 and all proration units surrounding these quarter quarter sections are being operated by Marbob in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool. There is therefore no offset operator which needs to be notified as to these locations.

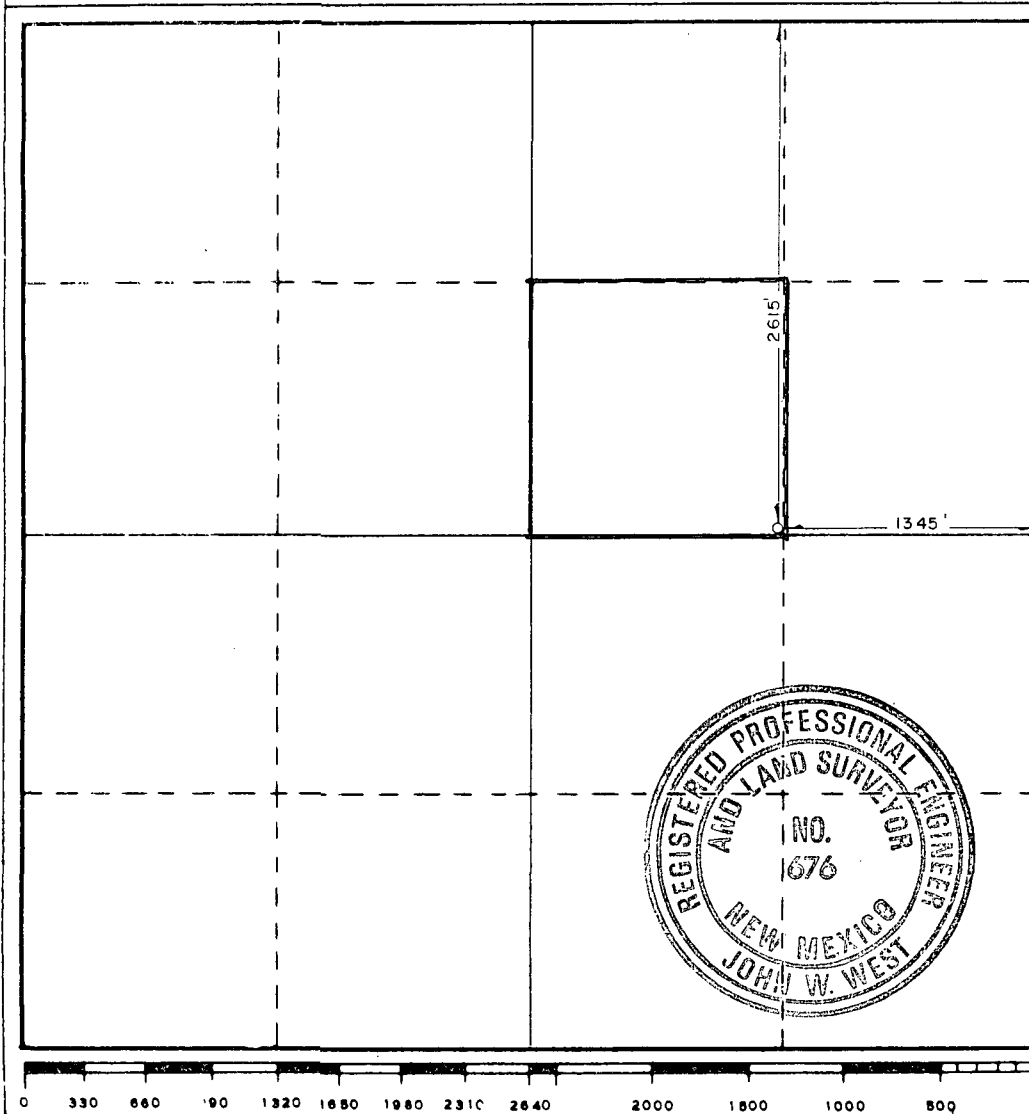

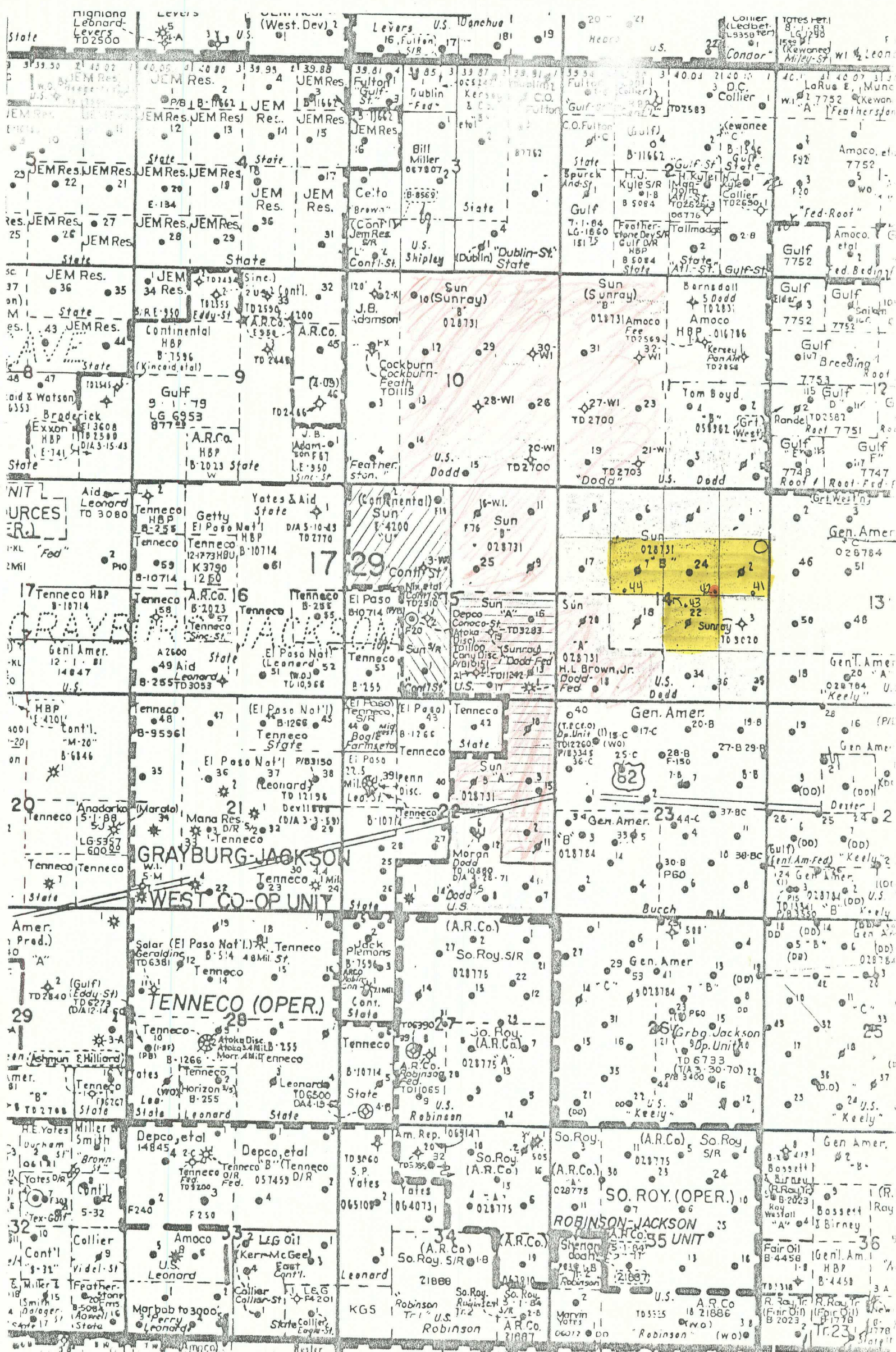
