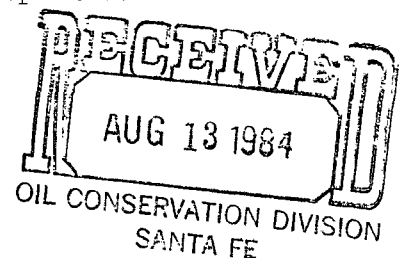
We propose to drill these wells as soon as possible. Your cooperation to expedite this request is appreciated. It is therefore requested that approval be granted for these unorthodox locations.

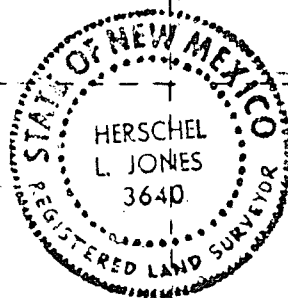

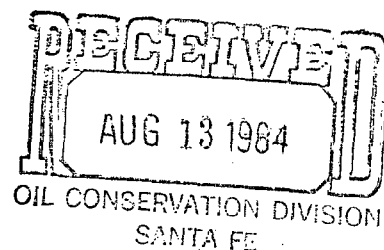
