

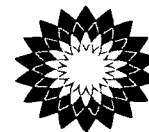

BP America Production Company respectfully requests authorization to surface commingle gas production from the Basin Fruitland Coal production from GCU 178 & Kutz Pictured Cliffs, West production from the GCU 62. Gas production from each well will be individually metered prior to surface commingling. After metering, the gas will be commingled prior to compression and entrance into the sales line.

The GCU 178 will be plugged back from Dakota and recompleted to the Basin Fruitland Coal. Therefore at this time we do not have commingled production numbers or gravity/BTU for the GCU 178.

Site Facility Schematic Flow Diagram

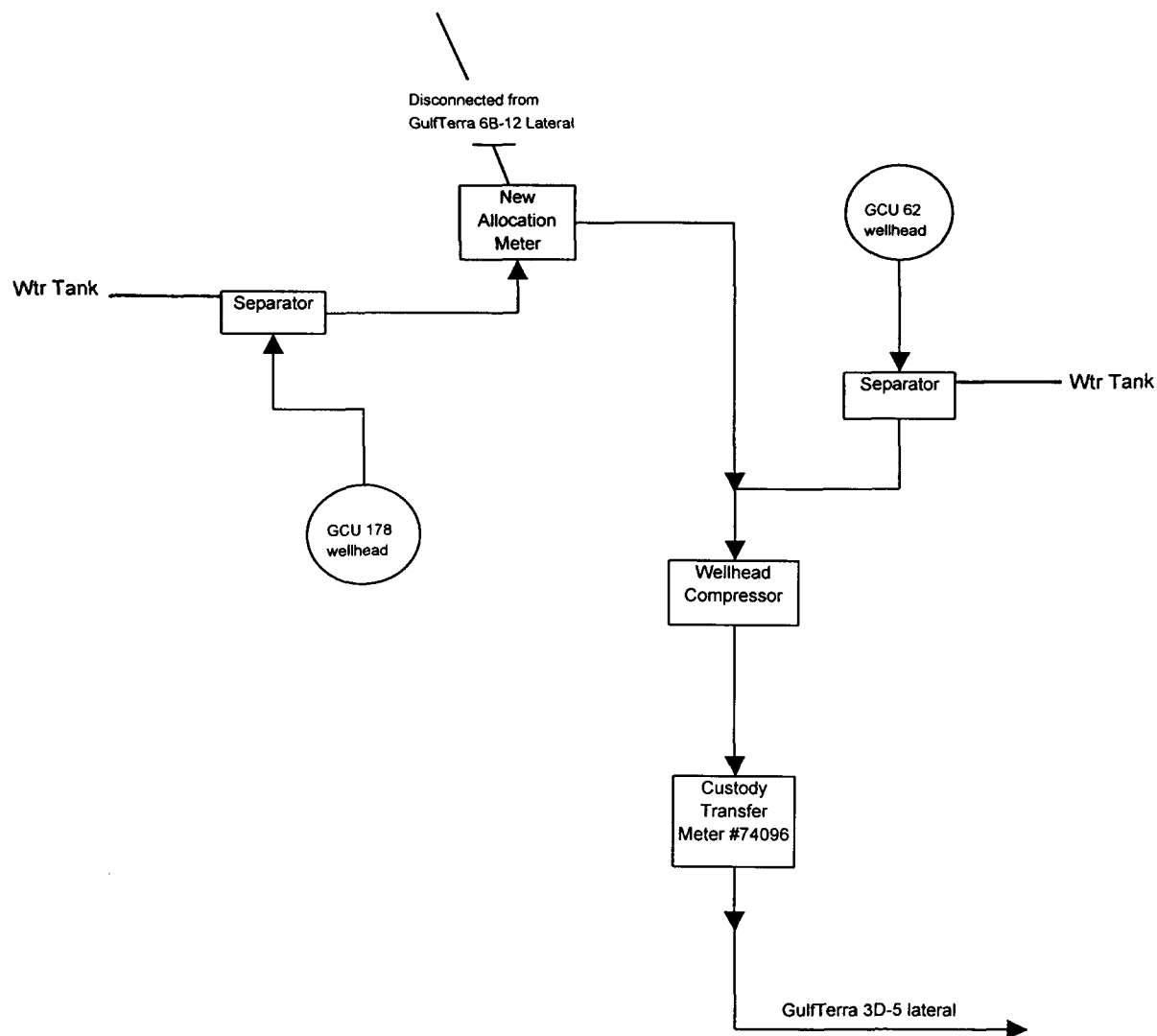

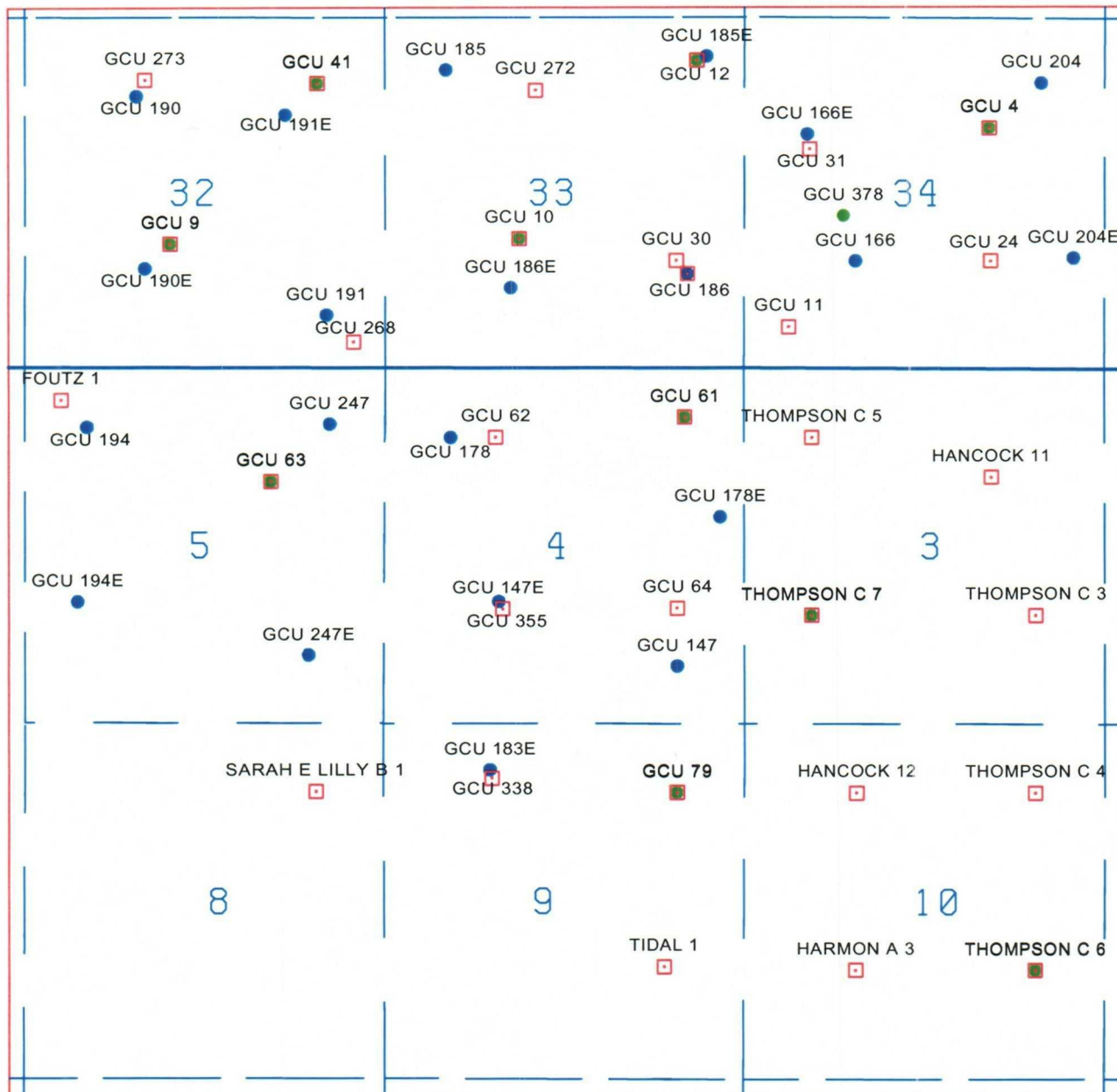
