Gentlemen:

You are respectfully requested to grant Administrative approval for an unorthodox location for the referenced wildcat gas well in accordance with Rule 104 F.

This well was drilled 330' FSL and 330' FWL of Sec.14, T.9S., R.32E, at a standard oil well location. The Devonian was perforated 11,055' to 11,060' and was determined to be non-commercial in that zone. The well was subsequently plugged back to the Atoka-Morrow zone, 10,030' to 10,036', where it appears to be a commercial gas well. Enclosed is a copy of C-101, Application to Plug Back and Amended Acreage Dedication Plat for the well.

Approval of this application would afford the applicant the opportunity to produce its just and equitable share of the gas from this undesignated pool and prevent the economic waste caused by drilling of unnecessary wells.

Dear Mr. Hill:

We have received your letter dated June 13, 1985 stating your objection to the above-referenced application for a non-standard gas well location. According to the Oil Conservation Division's Rules and Regulations, specifically Rule 104 F IV, an applicant seeking approval of an unorthodox well location must notify all offset operators of his intention. After such notification has taken place, offset operators have twenty days in which to respond to the application, either by signing a waiver of objection or by entering an objection.

Since notice of the application was sent to you by the applicant on May 3, 1985, your objection dated June 13, 1985 is not timely. Moreover, because your objection was not received within twenty days of notice to you of the application, and because no other offset operators objected, the application has been granted administratively. A copy of the approval is enclosed.
