

Gentlemen: New Well Name: Tuesday 'A' Federal Corn No. 1

Request for an Unorthodox Location on the Proposed Tuesday Federal No. 3, 1400' FNL and 990' FWL, Section 3-20S-29E, Eddy County, New Mexico

Conoco respectfully requests approval of an unorthodox location for the subject well based upon geologic considerations. The Tuesday Federal No. 3 well will attempt to further develop the Morrow reserves discovered by the Tuesday Federal No. 1 well. As shown on the attached NEG isopach map of the Upper Morrow sand, the target area is extremely limited in the east-west directions. Essentially, the reservoir is a narrow north-south trending channel. In addition to the Morrow formation, the Tuesday Federal No. 3 well will test the Strawn and Wolfcamp horizons. Based upon well control in the area and the attached isopach maps, the requested location provides the best opportunity to test each of the three zones. The well is planned to be completed to the Morrow and Strawn formations as a dual gas producer. The commerciality of the well depends upon the completion of two of the three zones to be tested, as is the case in the previously completed Tuesday Federal No. 1 well.

The enclosed Well Location Plat (form C-102) reflects that the location meets the requirements for administrative approval because it is not closer than 660' to the nearest side boundary or closer than 990' to the nearest end boundary of the proration unit.


