

Describe Cause of Problem and Remedial Action Taken.\* **Leak was discovered by lease operator 89:00am. Line was immediately shut in. Leak occurred in on a steel connection in a buried fiberglass line, corrosion. Vacuum truck was called and picked up 50 bbls of free standing produced water. Approximately 150 barrels of produced water were spilled. Average chlorides for this water is 13000 ppm.**


Describe Area Affected and Cleanup Action Taken.\* **Spill was in sandy area with limited vegetation. Contaminated soil will be removed down to NMOCD standards and replaced with clean soil. See attached map of spill site. According to NMOSE website, nearest depth to ground water found (sec 5) is 106' giving a ranking of 10**
