

Request for Unorthodox Location -
Britt B No. 28, 2280' FSL & 2020' FWL,
Section 15, T20S, R37E, Lea County,
New Mexico. Skaggs Abo Gas Pool

Conoco Inc. respectfully requests administrative approval for an unorthodox location for the subject well.

Previous administrative approval for an unorthodox location was received for this well in the Cass Penn Pool under NSL-2573. However, based on better than expected log response in the Abo, we are currently proposing to dually complete the well in the Cass Penn and Skaggs Abo pools.

As was stated in our original application this location was necessary to avoid a powerline which exists approximately 150' south of this location and runs west-northwest to east-southeast.
