Gentlemen:

An Exception to Rule 104 C.I. by administrative approval is requested for Texaco Producing Inc.'s Vacuum Grayburg San Andres Unit Well Nos. 141 and 147. The wells are located as follows:

Well No. 141: 1980' FNL, 1309' FWL, Sec. 1, T-18-S, R-34-E

Well No. 147: 1361' FNL, 660' FEL, Sec. 2, T-18-S, R-34-E

The wells must be drilled in these locations to ensure proper development of 20-acre spacing. Wells drilled previously on 20-acre spacing on our adjacent Central Vacuum Unit have proven to be viable wells. These wells will be completed in the Grayburg San Andres formation.

It should be noted that there are no affected Offset Operators to Well Nos. 141 and 147.

Attached are Forms C-102 for each well, and a lease plat showing the existing wells and locations of the subject wells.

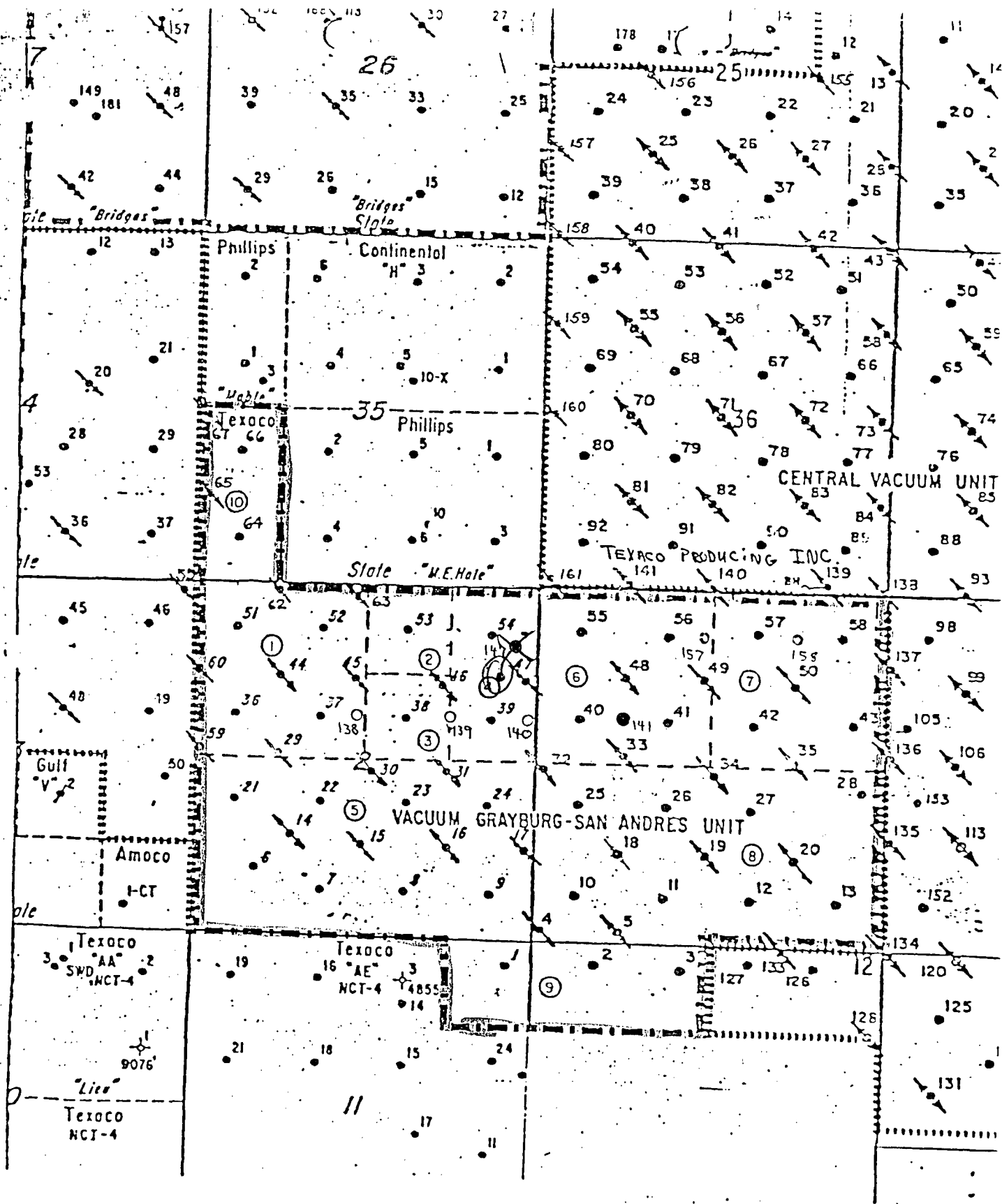


