Dear Mr. Basham:

Reference is made to your application dated March 21, 1990 for a non-standard oil well location to permit the completion of an efficient production/injection pattern within an active secondary recovery project for your Vacuum Grayburg San Andres Unit Well No. 149 to be located 1310 feet from the North line and 1980 feet from the West line (Unit C) of Section 1, Township 18 South, Range 34 East, NMPM, Vacuum Grayburg San Andres Pool, Vacuum Grayburg San Andres Pressure Maintenance Project Area, Lea County, New Mexico. Said well to be dedicated to the existing standard 40.70-acre oil spacing and proration unit comprising Lot 3 of said Section 1.

By the authority granted me under the provisions of General Rule 104 F(I), the above-described unorthodox oil well location is hereby approved.

Amended Administrative Order NSL-2795

Reference is made to your application dated May 29, 1990 to amend Division Administrative Order NSL-2795, dated May 15, 1990, which authorized an unorthodox oil well location for your Vacuum Grayburg San Andres Unit Well No. 149 to be drilled 1310 feet from the North line and 1980 feet from the West line (Unit C) of Irregular Section 1, Township 18 South, Range 34 East, NMPM, Vacuum Grayburg San Andres Pool, Vacuum Grayburg San Andres Pressure Maintenance Project Area, Lea County, New Mexico.


It is my understanding that said location is to be moved 20 feet south to avoid an East/West pipeline that was apparently unknown to exist at the time the original application was filed.

Therefore, by the authority granted me under the provisions of General Rule 104 F(I), said Order NSL-2795 shall be amended to reflect the proper location of said Well No. 149:

"1330 feet from the North line and 1980 feet from
the West line."

All other provisions of said original order shall remain in full force and effect until further notice.
