Dear Mr. Gentry:

A field investigation was conducted on July 23, 1990 by yourself and Dale Wirth of my staff on Bonneville Fuels Corporation's Proposed Fullerton Federal 14-33 Gas Well. The well is located in Township 27 North, Range 11 West, Section 14, 1850 feet FSL and 1850 feet FEL, Federal Lease SF-078094. The proposed access road will require a large cut to climb over the ridge and a sharp turn to enter the proposed well pad. The proposed well pad will require a 23 foot cut in the northwest corner, 18 foot cut in the southwest corner and is bordered by a cliff edge on the east side.

Due to the extreme nature of the topography, fragile soil conditions, significant disturbance, and difficulty in reclamation, we recommend that the site be relocated farther west. We consulted with our resource geologist and feel that relocation of the proposed well will not compromise the integrity of the pictured cliffs formation.

A field investigation was conducted by Dale Wirth and yourself on August 14, 1990 for the new staking location of 2420 feet FSL and 1995 feet FEL. This location will avoid the large cuts required for the access road and well pad and will minimize significant disturbance to the topography and soils, and improve reclamation. We prefer this location over the originally proposed location for the Fullerton Federal 14-33.
