
Reference is made to your application dated December 21, 1993 for a non-standard Basin-Fruitland coal gas well location for the existing Huerfano Unit Well No. 238 (API No. 30-045-21409) located 990 feet from the South and East lines (Lot 4/Unit P) of Section 36, Township 27 North, Range 10 West, NMPM, San Juan County, New Mexico.

Review of this application and Division records indicates that prior authorization from the Division was granted Meridian Oil, Inc. for the recompletion of this well to the Fruitland Coal interval at an unorthodox coal gas well location by Administrative Order NSL-2934, dated November 7, 1990.

The only change indicated by your December 21st application from the previous authorization is to include perforations into the Undesignated Fulcher Kutz-Pictured Cliffs Pool and to permit the downhole commingling of Pictured Cliffs and Fruitland Coal gas.
