Dear Mr. Newport:

Reference is made to your applications dated September 5 and October 23, 1990 for two non-standard producing oil well locations to permit the completion of an efficient production/injection pattern within the Lovington-San Andres Unit Waterflood Project, Lea County, New Mexico. Both wells are to be dedicated to an existing standard 40-acre oil spacing and proration unit comprising the SW/4 SW/4 (Unit M) of Section 36, Township 16 South, Range 36 East, NMPM, Lovington-Grayburg-San Andres Pool, Lea County, New Mexico.

By the authority granted me under the provisions of General Rule 104F(I), both of the following described unorthodox oil well locations are hereby approved.

- ✓ Lovington San Andres Unit Well No. 63  
100' FSL - 115' FWL; and
- ✓ Lovington San Andres Unit Well No. 65  
1168' FSL - 1330' FWL.


