
Mewbourne Oil Company finds it necessary to apply for and receive an unorthodox location to drill its Chalk Bluff Federal #2 in the North Illinois Camp - Morrow Gas Pool. Due to the proximity of buried gas pipelines for a legal location of 1980' FN & WL's, Section 1, T18S-R27E, we found a drillable location at 1650' FNL & 1350' FWL of Section 1, T18S-R27E which is far enough away from all buried pipelines (see enclosed survey plats). The enclosed topographic map shows this location to be in an area with the least amount of surface relief in the NW/4 of the section. Mewbourne has farmed in a 50% interest of the operating rights in the N/2 of the section from the base of the Abo to the Mississippian Barnett.

The enclosed isopach map of the Lower Morrow "Pink" Sand shows that the unorthodox location we require will not geologically enhance the chances of our making an economic well. This map is typical of our interpretation of the depositional trends for the primary objective Lower Morrow Sands. Atoka-Morrow Stratigraphic Cross Section F to F' shows the Lower Morrow Sands we hope to encounter in the well.

Mewbourne Oil Company feels that the proposed unorthodox location is reasonable and necessary to allow us to drill a Morrow test on our acreage. Accordingly, the offset operators have been advised of our intentions to apply for our unorthodox location.
