Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

Chevron is planning to drill and complete the **Arnott Ramsay (NCT-C) Well No. 16** in the Eumont Yates 7 Rvrs Qn (Pro Gas) Pool. It is also our desire to simultaneously dedicate the existing 640-acre Eumont Gas Proration Unit currently assigned to our Arnott Ramsay (NCT-C) Well Nos. 5, 13, and 15 [Administrative Order NSL-3007-A(SD)] to all four wells. The 640-acre gas proration unit comprises all of Section 21, Township 21 South, Range 36 East, Lea County, New Mexico.

As a result, the proposed location for the Arnott Ramsay (NCT-C) Well No. 16 of 1780 feet FNL and 660 feet FEL, Unit Letter H, Section 21, Township 21 South, Range 36 East, Lea County, New Mexico is unorthodox.

In order to prevent waste, Chevron respectfully requests your approval of this administrative application for an unorthodox gas well location and simultaneous dedication. Attached is a map showing offset operators and a Form C-102 plat. A copy of this letter and attachments are being furnished by Certified Mail to offset operators as their notice of this application.
