Gentlemen:

We are currently in the process of filing a C-101 and C-102 with the New Mexico Oil Conservation Division's district office in Hobbs for permission to recomplete an existing oil well to an Eumont (Gas) well. The well will be in the same zone as another Eumont gas well on an existing 160-acre proration unit comprised of the N/2 S/2 Section 7, T22S, R37E, Unit L, Lea County, New Mexico. The subject proration unit is currently dedicated our Mattern Lease #1 located in Section T22S, R37E, Unit L. I hereby file for administrative approval to simultaneously dedicate the 160-acre proration unit, consisting of the N/2 S/2 Sec. 7 to both our existing well (Mattern #1) located in Sec. 7, T22S, R37E, Unit L and our proposed recompletion well (Mattern #2) located in Sec. 7, T22S, R37E Unit K. The Mattern No. 2 is currently a TA'd Arrowhead Grayburg oil well.

Three copies of a plat showing the location of the original well on the existing 160-acre proration unit plus the location of the proposed well are enclosed.

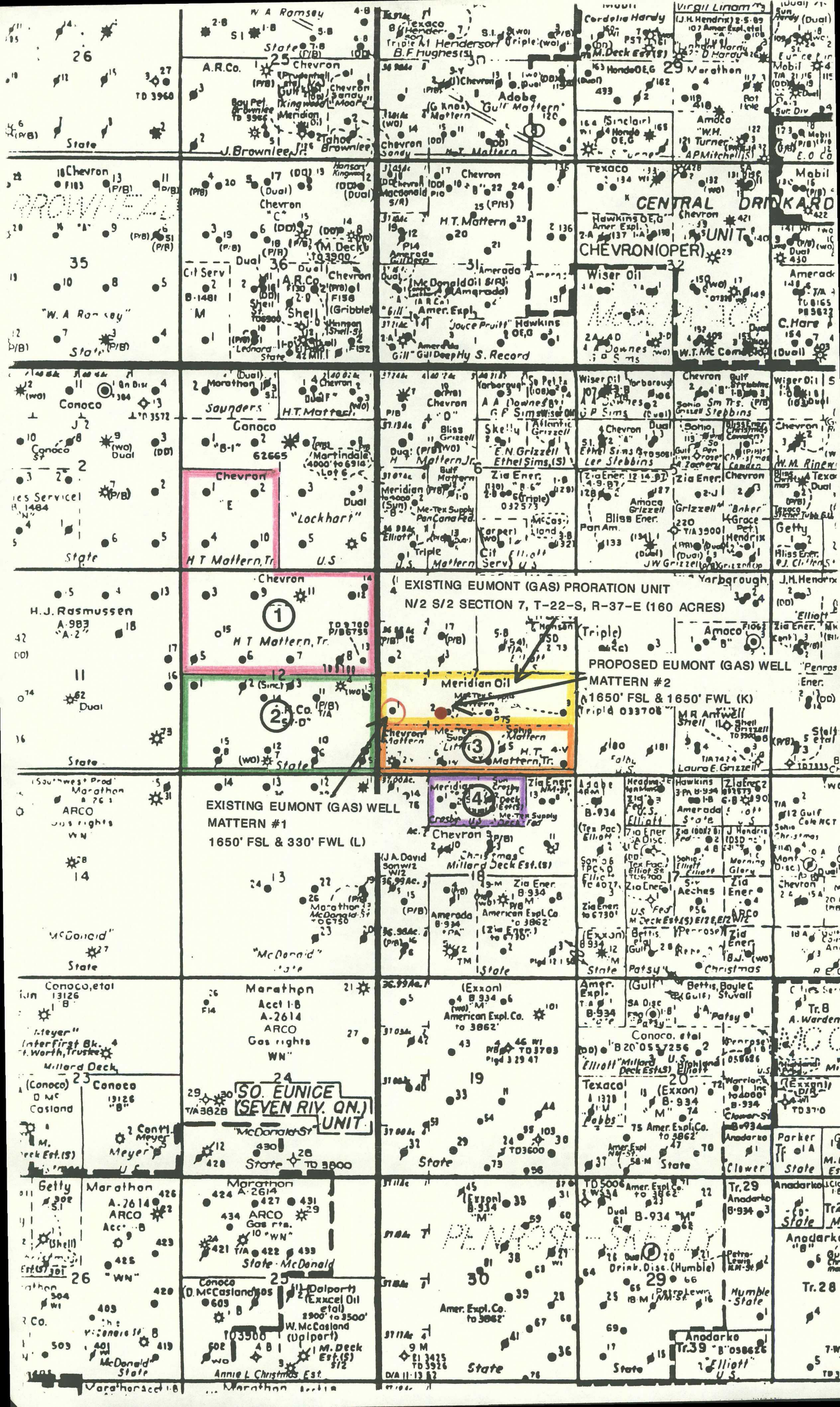

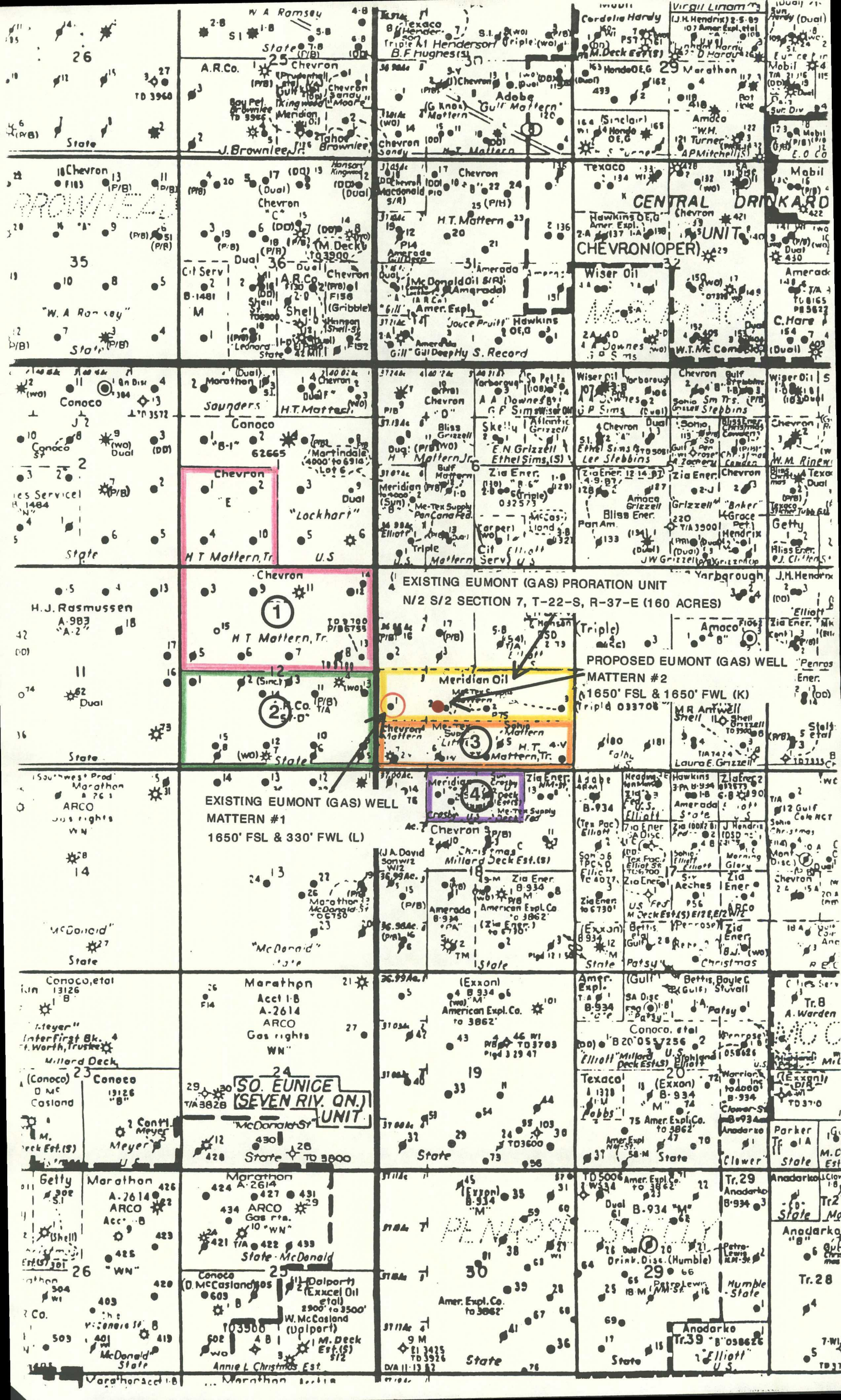

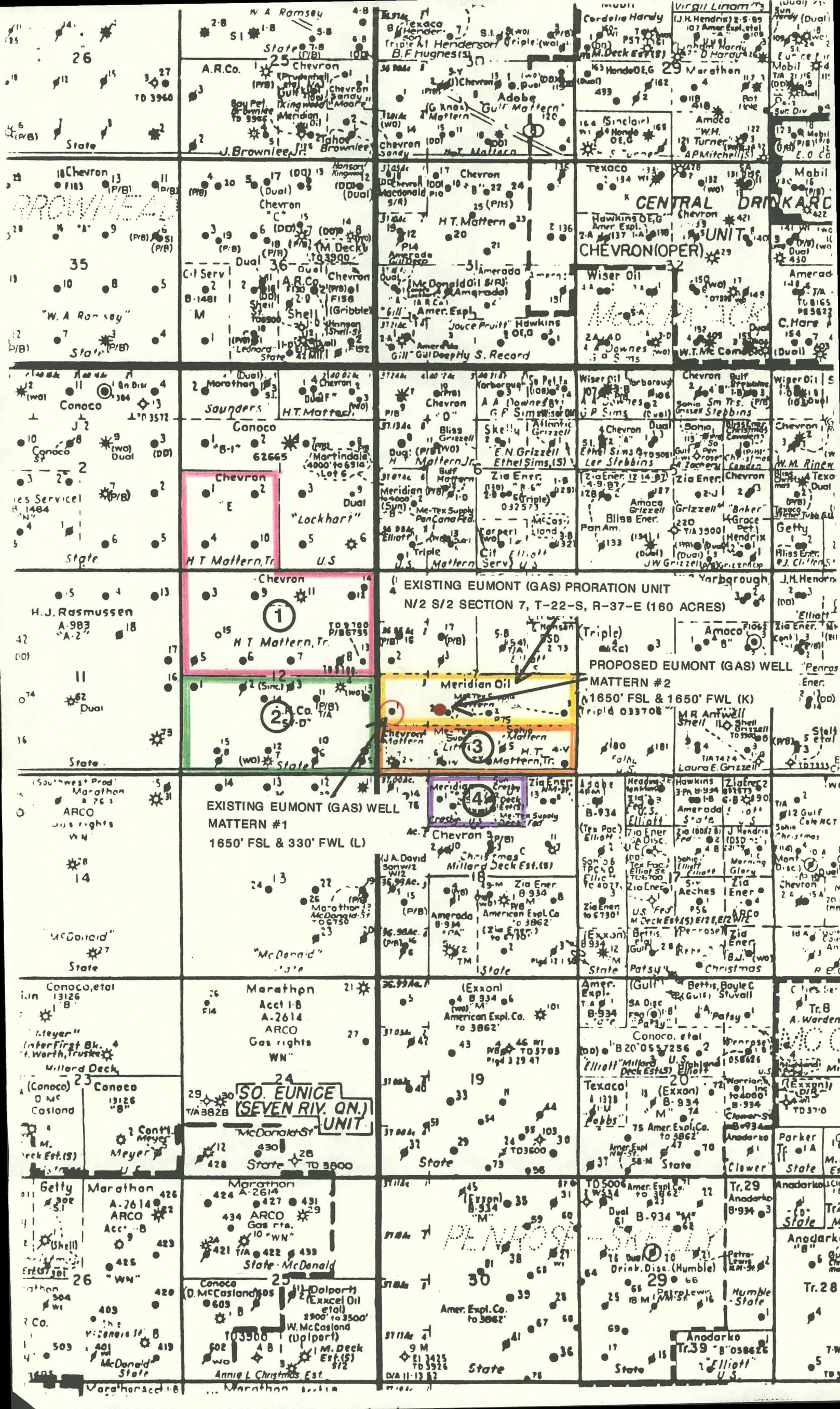
