Gentlemen:

Per your instructions and referencing Division Order NSL-3074 signed on November 8, 1991, please find attached an OCD Form C-102 which shows an ammended location for the proposed EMSU infill Well No. 624 due to a buried pipeline.

The pipeline was discovered while building the drilling pad and site for this subject well. The new location is 1410 feet FEL and 2580 feet FSL, Unit R, Section 5, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico. This ammended location actually becomes more standard as a result of moving it to avoid the pipeline.

Your prompt response in granting our original application and in allowing us to proceed with the drilling of the subject well in view of this late location change is greatly appreciated. It has enabled us to facilitate drilling rig aquisition and movement avoiding considerable extra expense.


