I just received DHC-3962 covering SDX's Enron State #2 (API 30-015-31920). All appears OK with it. I also received Surface Commingling Order PC-1096-B which includes the new pool completed in the Enron #2 well. Included in the DHC application was a copy of a C-103 (that we submitted about the same time) that asked to add a new infill well on this lease (Enron State #12 30-015- 35050) to the existing surface commingle permit. I noticed that it was not included in the new surface commingle order. It probably had not been processed yet.

Should we amend PC-1096-B to include it, or would it be better to issue a new PC order. Sorry for the inconvenience, but these two applications were sent in at about the same time. Thanks for your help on this.

The interest is identical for both pools and all facilities are located on lease. The battery is located on location with the Enron State #1. Production from the Enron St #12 well from the Artesia, GL-YE pool (96830) will be commingled with production from the Enron State #1, #2 & #4 wells which are producing from the NE Red Lake GL-YE (96836) pool, the Artesia, QN-GB-SA (03230) pool and the Red Lake, QN-GB-SA (51300) pool under PC-1096A. Production to be allocated by periodic test.






