Dear Mr. Stogner:

Mitchell Energy Corporation hereby requests administrative approval of an unorthodox location for the referenced well pursuant to Rule 104 F. and for a non-standard unit pursuant to Rule 104 D.(2)(a). We plan to drill to a depth sufficient to test the Morrow formation. An unorthodox location is needed for topographic reasons. The well was originally proposed as an orthodox location (660' FWL & 1980' FNL); however, the location was moved a short distance to avoid underground water lines (aqueducts). The new location is 710' FWL and 1900' FNL. Note that the proposed spacing unit for this well, being the west half of section 18, covers 288.56 acres; therefore non-standard unit approval is also necessary.

Enclosed please find two plats showing the location of the proposed well and the aqueducts. Also enclosed are Forms C-101, C-102 and a plat showing offset operators and unleased mineral owners. A copy of this application has been sent to each of these parties, along with a request for a waiver of objection.
