Dear Mr. LeMay / Mr. Sexton:

ARCO Oil and Gas Company respectfully requests administrative approval for an unorthodox Eumont gas well location for the State 176 #5 and State 176 #7, located 990' FNL, 330' FWL and 1650' FNL, 1650' FWL, respectively, in Section 19, T-21S, R-36E, Lea County, New Mexico. The State 176 #5 was a Eumont oil well which ARCO worked over earlier this year and its GOR has changed to a gas well. The State 176 #7 is a Eumont oil well which ARCO is preparing to workover, and expects its GOR to also change to a gas well. At the same time, ARCO requests simultaneous dedication of the Eumont gas production from the State 176 #3, #4, and #6 with the Eumont gas production from the State 176 #5 and State 176 #7 wells. The State 176 #3, #4, and #6 are Eumont gas wells currently dedicated to an existing 275-acre proration unit (R-5323) located in Section 19, T-21S, R-36E.

Attached are C-102 forms identifying the configuration of the subject 275-acre Eumont gas proration unit. Also attached is a list of offset operators for this unit, and a land plat map of the surrounding area.

ARCO Oil and Gas Company believes approval of this request will be in the interest of conservation, will protect correlative rights, and will allow for a more complete recovery of Eumont gas reserves from the subject acreage.



ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 20, 1958, at Santa Fe, New Mexico, before Elvis A. Utz, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 16<sup>th</sup> day of October, 1958, the Commission, a quorum being present, having considered the application, the evidence adduced and the recommendations of the Examiner, Elvis A. Utz, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Sinclair Oil & Gas Company, is the operator of the W/2 E/2, E/2 NW/4 and the NW/4 NW/4 of Section 19, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico.
- (3) That the applicant is the operator of the Sinclair State 176 Well No. 3, located 2310 feet from the South line and 1650 feet from the East line of said Section 19.
- (4) That the applicant proposes the establishment of a 275-acre non-standard gas proration unit in the Eumont Gas Pool, consisting of the above-described acreage, to be dedicated to the aforementioned Sinclair State 176 Well No. 3.
- (5) That the NW/4 NW/4 of said Section 19 cannot reasonably be presumed to be productive of gas in the perforated interval of the said Sinclair State 176 Well No. 3.

(6) That the said Sinclair State 176 Well No. 3 should be assigned a 240-acre non-standard gas proration unit instead of a 275-acre non-standard unit, said 240-acre unit to comprise the W/2 E/2 and E/2 NW/4 of said Section 19.

IT IS THEREFORE ORDERED:

(1) That the application of Sinclair Oil & Gas Company for the establishment of a 275-acre non-standard gas proration unit in the Eumont Gas Pool to consist of the W/2 E/2, E/2 NW/4 and the NW/4 NW/4 of Section 19, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico, and to be dedicated to the applicant's State 176 Well No. 3, located 2310 feet from the South line and 1650 feet from the East line of said Section 19, be and the same is hereby denied.

(2) That a 240-acre non-standard gas proration unit in the Eumont Gas Pool, consisting of the W/2 E/2 and the E/2 NW/4 of said Section 19, be and the same is hereby established, said unit to be dedicated to the above-described Sinclair State 176 Well No. 3.

(3) That Administrative Order NSP-43 be and the same is hereby superseded.

(4) That the said Sinclair State 176 Well No. 3 be assigned an allowable in the proportion that the acreage in the non-standard gas proration unit established above bears to the acreage in a standard gas proration unit for the Eumont Gas Pool, subject to the provisions of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order No. R-520.





NOW, on this 25th day of January, 1977, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Atlantic Richfield Company, is the operator of a previously established 275-acre Eumont gas proration unit comprising the W/2 E/2, N/2 NW/4, and SE/4 NW/4 of Section 19, Township 21 South, Range 36 East, NMPM, Eumont Gas Pool, Lea County, New Mexico.

(3) That the applicant seeks to simultaneously dedicate to said non-standard unit its State 176 Wells Nos. 2, 3, 4, and 6, located at unorthodox locations in Units O, J, G, and C, respectively, of said Section 19.

(4) That the above-described wells at said unorthodox locations will better enable applicant to produce the gas underlying the proration unit.

(5) That no offset operator objected to the proposed unorthodox locations.

(6) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the gas in the subject pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

(7) That Commission Order No. R-5323 dated November 30, 1976, which approved the aforesaid non-standard proration unit dedicated to the State 176 Wells Nos. 3 and 6 only, should be superseded.

IT IS THEREFORE ORDERED:

(1) That the applicant, Atlantic Richfield Company, is hereby authorized to simultaneously dedicate to a previously approved 275-acre Eumont gas proration unit comprising the W/2 E/2, N/2 NW/4, and SE/4 NW/4 of Section 19, Township 21 South, Range 36 East, NMPM, Eumont Gas Pool, Lea County, New Mexico, its State 176 Wells Nos. 2, 3, 4, and 6, located at unorthodox locations in Units O, J, G, and C, respectively, of said Section 19.

(2) That the allowable assigned to the above-described gas proration unit shall be based upon the unit size of 275 acres, and that the operator may produce the allowable assigned to the unit from the subject wells in any proportion.




