Gentlemen:

Chevron U.S.A. Inc. respectfully requests administrative approval for an unorthodox gas well location on the J. N. Carson NCT-A well # 7. This well is in an existing non-standard gas proration unit, which consists of 160 acres. Currently J. N. Carson wells # 9 and # 10 are simultaneously dedicated to this 160 acre proration unit. Well # 7 is being proposed to be abandoned in the current Drinkard zone and recompleted into the Blinebry Oil & Gas zone. All three wells are proposed to be simultaneously dedicated to this 160 acre proration unit. In support of this application, Chevron U.S.A. Inc. states the following facts:

- 1) The 160 acre gas proration unit is already approved.
- 2) Well # 9 produces approximately 0 bopd and 480 mcfpd and well # 10 produces approximately 4 bopd and 200 mcfpd. The allowable is set at approximately 1250 mcfpd, which leaves about 570 mcfpd available.


- 3) Chevron's J. N. Carson well no 7 is located 510' from the southern border and 460' from the western border of the proration unit. The closest Blinebry well is Mobil's E. O. Carson # 14, located at 731' FNL & 1909' FWL of Section 33, approximately 1100' west of well # 7.

Attached is a plat outlining the proration unit with the location of wells 7, 9, and 10, and a map showing all offset properties and wells.

Chevron U.S.A. Inc. has mailed, by certified mail, a copy of this application to the offset Operators.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on February 27, 1974, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 6th day of March, 1974, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Gulf Oil Corporation, seeks approval for a non-standard 160-acre gas proration unit comprising the NE/4 SW/4 and W/2 SE/4 of Section 28, and the NW/4 NE/4 of Section 33, both in Township 21 South, Range 37 East, NMPM, Blinbry Oil and Gas Pool, Lea County, New Mexico.
- (3) That the applicant seeks to simultaneously dedicate to said non-standard unit its J. N. Carson Wells Nos. 4 and 9 located in Units O and K, respectively, of Section 28, with unit production to be taken from said wells in any proportion.
- (4) That the proposed non-standard gas proration unit can be efficiently and economically drained and developed by the subject wells.
- (5) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the gas in the Blinbry Oil and Gas Pool and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:


(1) That effective at 7:00 a.m. March 1, 1974, the applicant, Gulf Oil Corporation, is hereby authorized to simultaneously dedicate a non-standard 160-acre gas proration unit comprising the NE/4 SW/4 and W/2 SE/4 of Section 28, and the NW/4 NE/4 of Section 33, both in Township 21 South, Range 37 East, NMPM, Blinebry Oil and Gas Pool, Lea County, New Mexico, to its J. N. Carson Wells Nos. 4 and 9 located in Units O and K, respectively, of said Section 28 with unit production to be taken from said wells in any proportion.

(2) That the allowable assigned to the above-described gas proration unit shall be based upon the unit size of 160 acres and that the operator may produce the allowable assigned to the unit from the subject wells in any proportion.

(3) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
