

Describe Cause of Problem and Remedial Action Taken.\*

**On Wednesday January 2, 2008 at 1130 hrs, a leak was discovered coming from the surface casing valve on EVGSAU well #2642-001. Amount spilled was 25 bbls of produced water.**

Describe Area Affected and Cleanup Action Taken.\*

**The spill was not contained and affected approximately 4,000 sq/ft of pad and pasture. The MSO shut in the well and called a vacuum truck to pick up free liquids. 8 bbls of produced water was recovered. The spill site will be delineated and remediated in accordance with NMOCD guidelines. The Chloride concentration is 53,000 for this lease.**
