The New Mexico Oil Conservation Division (OCD) has received the Addendum to the Stage 1 and 2 Abatement Plan for the 34 Junction South Station Release Site, dated May 9, 2008, and has conducted a review of the Addendum. The Addendum, submitted for the above-referenced site, indicates that Plains has met the requirements of OCD Rule 19 for a Stage 1 and Stage 2 Abatement Plan. Therefore, the OCD hereby conditionally approves the Stage 1 and 2 Abatement Plan for above-referenced site, dated October 2006, including the Addendum in accordance with Rule 19.H:

Plains must submit proof of public notice to demonstrate compliance with Rule 19.G to the OCD within 30 days.

Dear Ms. Reynolds:

The New Mexico Oil Conservation Division (NMOCD) has reviewed the submitted Stage 1 and 2 Abatement Plan (AP-63) dated October 2006 and draft Public Notice, submitted February 19, 2008, for the above referenced site. The NMOCD hereby deems the Stage 1 & 2 Abatement Plan (AP-63) (was 1R-0456) administratively complete.

Please keep in mind that the NMOCD cannot approve of the Plan until at least 30 days after you have provided public notice (which must be provided within 15 days). However, to expedite the approval process, the NMOCD recommends that the following amendments are made to the Plan:

1. The Abatement Options will include proposed additional borings near RW-1 and MW-3 to be sampled at the same sample intervals as the original RW-1 and MW-3, respectively, and the samples will be analyzed for BTEX and TPH.
2. The Abatement Options will include a provision that once the samples have been analyzed, the soil abatement options may be addressed further prior to implementing the currently proposed soil abatement plan.

Also, the NMOCD hereby approves the Public Notice for the Stage 1 & 2 Abatement Plan (AP-63) as submitted.
