Mechanical seal wore out on the water transfer pump, causing leak on pump The seal was replaced on the transfer pump

Describe Area Affected and Cleanup Action Taken.*
The impacted area was the bermed area of the tank battery. The west side of the bermed area is lined with a 20 Mil. Liner The east side of the bermed area is not lined. Soil samples will be taken for analytical from the impacted area on the east side of the berm. Soil samples will be sent to a second party lab & analysis ran for TPH, B-tex & chlorides. If the initial analytical results find the TPH & B-tex to be over the RRAL A work plan will be submitted to OCD for the correction of the hydrocarbons When Analytical results reflect the TPH & B-tex to be under the RRAL. The Chlorides will be documented. A final C-141 form will be submitted to the OCD requesting closure for the release that occurred on 2/10/2008. Free waters were recovered from the lined area of the berm, no further corrective actions will be taken on the west side of the bermed area.
