Dear Mr. Brooks,

BC Operating is requesting a non-standard location for the above mentioned well. The location of this well is 1435' FNL and 757' FEL of Sec 36, T12S, R31E. We plan to re-enter this well and complete in the Caprock Wolfcamp (9180). This pool is 40 acre spacing and per statewide rules, we can only be 330' from the quarter-quarter of the section. Our location is 1435' FNL making us 215' unorthodox to the North.

The well to the north of our well was plugged on 6/14/66. As shown on the enclosed map, BC owns 600 acres in Sec 36, T12S-R31E. The working, royalty and overriding interest owners are common to all depths on this lease. No offset operators or owners need to be notified.


