Dear Mr. LeMay:

I am hereby requesting administrative approval for an exception to NMOCO Rule 104 concerning well spacing. This well was originally completed in the Gallup formation at a location 1870' from the South line and 800' from the West line of Section 18-T24N-R6W in Rio Arriba County.

We reached the economic limit of Gallup production and plugged the well back to the Pictured Cliffs formation in late July of this year. The well is presently producing into the pipeline from the Pictured Cliffs formation.

Today I realized while filling out the appropriate forms the existing wellbore was 20 feet top far North of the South line to be a standard Pictured Cliffs completion. This letter requesting an exception is the result of my calling your Aztec office to advise them of the error. I will be happy to furnish anything further you may need.
