Santa Fe Energy Operating Partners, L.P. hereby requests administrative approval of an unorthodox gas well location for the following well:

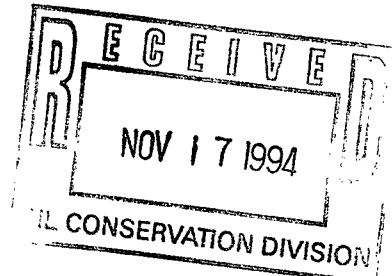
Harroun 32 State Com. Well No. 1
660 Feet FNL and 1180 Feet FWL
N½ of Section 32 - 23 South - 29 East
Eddy County, New Mexico

The well will be drilled to a depth sufficient to test the Atoka formation (undesignated Laguna Salado-Atoka Gas Pool or undesignated South Culebra Bluff-Atoka Gas Pool). The ownership of the leases in the well unit is set forth on Exhibit A attached hereto. The well will be located on State of New Mexico Lease VB-380.

As requested by Division Memorandum 1-90, the following information is attached:

1. Form C-102. The Form C-102 for the subject well is attached hereto as Exhibit B.

2. Land Plat: A land plat is attached as Exhibit C, with the offset lessees or operators highlighted in yellow. A listing of all offset operators or lessees is attached hereto as Exhibit D. This information is from OCD well files, Exhibit C, and State Land Office and Bureau of Land Management lease files, and is current and correct.



3. Topographic Map: The original well location desired by Applicant was 1330 feet FWL and 660 feet FNL. However, said location was on top of a pipeline, as indicated on the topographic map attached as Exhibit E. As a result, Applicant has moved the location 150 feet to the West of the initial location.

4. Directional Drilling: The cost of drilling directionally to a standard bottom hole location is approximately \$150,000. The well nearest the proposed location to test the Atoka formation is the Texaco Malaga Harroun 31 Well No. 1, in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 31, which was not productive in the Atoka and was plugged back to the Delaware. As a result, the cost of directional drilling is not justified due to the risk involved.

5. Notice: Attached hereto as Exhibit F is an affidavit regarding notice to the offset operators and lessees, with copies of the notice letters attached thereto.

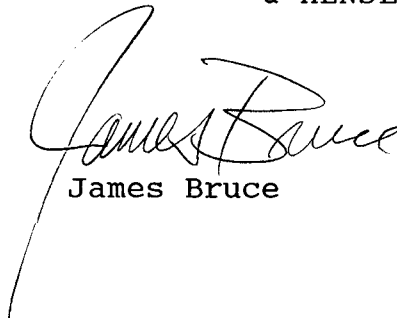
6. Geologic Information: The primary target of the well is the Atoka formation. There are two prospective zones in the Atoka: The Atoka Bank and the Atoka "AC" Sand. Attached as Exhibit G is an isopach of the Atoka Bank, with Atoka Bank producers marked by black circles. The unorthodox location is not required for the Atoka Bank. However, the estimated completed well cost is in excess of \$1.3 million. As a result, Applicant desires to stack prospective zones in order to lessen its risk. Therefore, Applicant seeks an unorthodox location for the subject well to increase the chance of successfully completing the well in the Atoka "AC" Sand. Attached as Exhibit H is an isopach of the Atoka "AC" Sand. Atoka "AC" Sand producers are marked by open circles. Also set forth are dates of first production, cumulative production through 12/93 (in BCF), and estimated ultimate recovery. In order to encounter approximately 5-10 feet of net sand in the Atoka "AC" Sand, the well location needs to be moved to the west of a standard location.
