Describe Cause of Problem and Remedial Action Taken.* **A Western Refining employee discovered a spill of approximately 19 BBL of condensate and 6 BBL of produced water at the Wood WN Fed #1 on the morning of 4/24/08 due to a leak in the production tank. The employee was gauging the tank before unloading when the plumb bob on tank gauge tape went through the bottom of the tank and got stuck. When he pulled the plumb bob back out, fluids started to flow out of the bottom of the tank. Upon discovery, the employee started pulling the fluids from the load line while another water truck pulled oil from the drain line.**

Describe Area Affected and Cleanup Action Taken.* **The spilled fluids were contained within the berm, and 5 BBL of condensate were recovered by vacuum truck and returned to production. The affected soils will be excavated. The tank will be removed and replaced with a new tank. To prevent reoccurrence, COPC will continue to perform monthly inspections of tanks.**
