Dear Mr. LeMay,

Giant Exploration & Production Company requests administrative approval from the New Mexico Oil Conservation Division for an unorthodox location for the subject well. This well is currently shut in due to uneconomic producing rates from the First South Bisti Sand of the Bisti Lower Gallup field. Giant Exploration & Production intends to recomplete this well in the Fruitland Coal formation. The proposed proration dedication for this well would be the 320 acres of the East Half (E/2). However, due to the location of the existing wellbore, this well would fall in an unorthodox location for a Fruitland Coal gas well.

The option of recompleting this well in the Fruitland Coal formation would be the most economical. Log analysis of the coal in this area indicates that decent potential exists for commercial gas rates from the Fruitland. Recompletion of the existing wellbore would be in the best interest of conservation.

Giant Exploration & Production Company is the lessee for all of Section 32. All offset leases are Federal and would carry the same royalty rate. Therefore, correlative rights would be protected. Notification was given to the Bureau of Land Management for informational purposes and no objection was received for the subject well and proposed action.


