- 1: BD SWD Jct N-32 vent submitted by Arcadis on 5/27/2008 #1R426-153

In Task 2 please include TDS and sulfate in the analysis of "general chemistry" for the groundwater sampling.

Also, in Task 2 the extent of impacts for chloride in the proposed soil borings must be delineated to 250 mg/Kg.
