GEOLOGIC DISCUSSION

Enron Oil & Gas Company is seeking approval for an unorthodox location in the Sand Tank area Eddy County, New Mexico, based on geologic reasons. Enron recently completed the Ranger "7" Federal Com. No. 1 (NE/4 Section 7-18S-30E) as a Morrow gas well in the Sand Tank Field. The proposed unorthodox location for the Sand Tank "7" Federal Com. No. 1 (W/2 proration unit/990' FNL & 990' FWL Section 7) is a northwest offset to Enron's new completion.

Enron's Ranger "7" Federal Com. No. 1 penetrated several sands in the middle Morrow. These clastics are interpreted as a NE-SW trending beach to near-shore system of discontinuous marine sands. The two thinner middle Morrow sands in the Ranger "7" wellbore are gas productive while the thicker third sand is wet based on electric log calculations with an average water saturation of 80% (refer to x-section A-A'). It is this wet sand, referred to as the Ranger sand, that is the basis for the unorthodox location.

The Ranger sand, as identified in the Enron Ranger "7" Federal Com. No. 1 is correlative with wells in the immediate area. Cross section A-A' ties the wet Ranger sand in Enron's well with a stratigraphically equivalent gas bearing sand in the downdip Southland Royalty (Meridian) Holly "8" Federal No. 1. This supports the discontinuous nature of these middle Morrow sands. The Ranger sand was isopached using neutron/density crossover as a basis for net clean sand because this particular sand is characterized by a high gamma ray reading (refer to isopach map). A structure map on top of the Ranger sand was also constructed indicating southeast dip. An estimated gas/water contact for the Ranger sand was placed at -7,713' (refer to structure map) or 20' above the sand top in the Ranger "7" wellbore. Twenty feet is considered reasonable as the sand is wet from top to bottom and no transition zone is indicated. The contact could be less, but it could also be more. The estimated gas/water contact was then overlain on the isopach of that Ranger sand body defined by the Enron, Ranger "7" Federal Com. No. 1 and the Yates Petroleum, Sand Tank APS Federal Com. No. 1 (Section 12-18S-29E); hence defining the productive limits of that sand body. Yates production tested gas from the Ranger sand in their well in Section 12 and the well is currently shut-in waiting on pipeline connection.

Using the estimated gas/water contact of -7,713' places all but one of the orthodox locations for a W/2 proration unit in Section 7 at or below water for the Ranger sand. The remaining orthodox location (1,980' FNL & 660' FWL) above the contact is shown as the open blue circle on the accompanying maps. This location is considered highly risky at best with regards to a sustained water free producing rate and commerciality over the life of the well. Enron believes the proposed unorthodox location will allow the participating parties to effectively recover hydrocarbons under the lease, protect correlative rights and prevent waste.





Enron Oil & Gas Company (Enron) proposes the drilling of the captioned test well at a location 990' FNL & 990' FWL of Section 7-18S-30E to a depth sufficient to test the Morrow formation, at an approximate total depth of 11,600'. In this regard, please find a plat showing the subject spacing unit (W/2), its proposed unorthodox well location, and offsetting spacing unit and leases. This well is being drilled at this location in order to move updip from the wet Morrow Sand encountered in Enron's Ranger "7" well in the E/2 of this Section 7.

Enron hereby seeks an exception to the well location requirements of the New Mexico Oil Conservation Division Rule 104.C and has applied pursuant to Division Rule 104F.(2) for administrative approval of an Unorthodox Location Drilling Permit for all formations through the base of the Morrow formation which may be developed on 320 acre proration units.

Enron has determined that the drilling of the proposed test well at the specified location is necessary and prudent in order to recover oil and gas reserves underlying the above referenced Section 7.
