

Dear Mr. LeMay:

Amoco Production Company hereby seeks administrative approval pursuant to the provisions of Division Rule 104 F (2) adopted on January 18, 1996, of an unorthodox well location for its Evelyn "35" State Com. Well No. 1 to be drilled at an unorthodox well location 1730 feet from the North line and 660 feet from the East line of Section 35, Township 17 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Attached hereto as Exhibit A is a plat showing the subject spacing unit, the proposed unorthodox well location, the offsetting wells and the diagonal and adjoining spacing units.

This unorthodox location is necessary for geological reasons. Attached as Exhibit B hereto is a Morrow Net Sand Map which shows that the proposed location is required if the Morrow reserves under this spacing unit are to be effectively drained.





