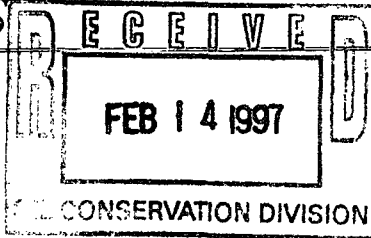

Burlington Resources is applying for administrative approval of a non-standard location for the above location in the Mesa Verde formation. This well was originally drilled and completed in 1995 as a pressure observation well only.
