Dear Sirs:

Burlington Resources proposes to drill the above reference well location as a commingled Basin Dakota and Blanco Mesaverde well and is applying for administrative approval of an unorthodox gas well location for both MV and DK formations.

The subject well was staked 1642' FSL & 2169' FWL, Sec. 12, T30N, R10W a non-standard location as per Order R-10987B(1 & 2). As shown on the topo map, the SW/4 of Section 12 is primarily in severe topographic terrain. There are also existing wells in the SW/4 of said section. The Grambling C #4, which is the same pool formation as the staked well, is at a needed 983' away to maintain adequate offset. The Grambling C #10 is in the SW/SW of Section 12, and is a PC formation which has an option of twinning. The existing PC pad was analyzed in the field by COPC representative, and determined not to have adequate room for an even larger Mesaverde/Dakota well location. This non-standard proposed location is the last possible option for this well.

To comply with the New Mexico Oil Conservation Division rules, we are submitting the following for your approval of this non-standard:

- > Approved application for Permit to Drill and C102 at referenced location
- > Offset operator plat
- > 9 section plat
- > Topography plat of Section 12

Production from the Basin Dakota and Blanco Mesaverde is included in the 294.98 acre gas spacing unit, the west half dedication of Section 12, T30N, R10W.

Burlington Resources, a wholly owned subsidiary of ConocoPhillips is the offset operator and has 100% working interest of the affected section, and therefore no notification is necessary.




