Pursuant to Division Rule 19.15.3.104F(2), Adventure Exploration Partners, LLC respectfully requests administrative approval of an unorthodox oil well location for its Klein Ranch "16" State Well No. 1 which is proposed to be drilled 467 feet from the South line and 1100 feet from the East line (Unit P) of Section 16, Township 19 South, Range 35 East, NMPM, Lea County, New Mexico, to test the Wolfcamp formation, Southeast Scharb-Wolfcamp Pool (Oil - 55650). The SE/4 SE/4 of Section 16 is to be dedicated to the well forming a standard 40-acre oil spacing and proration unit for said pool.

The Klein Ranch "16" State Well No. 1 is located within the Southeast Scharb-Wolfcamp Pool, which is currently governed by Division Rule 19.15.3.104(B). This rule requires standard 40-acre spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the proration unit.

The proposed unorthodox oil well location is necessitated by a combination of engineering and topographic considerations. The well is to be located within the southern portion of the SE/4 SE/4 of Section 16 in order to maximize the distance of this well from the existing Marks & Garner Production Ltd. Co. Lea/UA/State No. 1 (API No. 30-025-28484) which is located 2080 feet from the South line and 2070 feet from the East line (Unit J) of Section 16. This well cumulatively produced 240,646 barrels of oil and 209 MMCF of gas from the Southeast Scharb-Wolfcamp Pool. As shown on the attached topographic map (Attachment 1), there is a drainage ravine that runs northwest-southeast through the SE/4 SE/4 of Section 16. The presence of this drainage feature precludes locating the well at a standard well location.

Secondary objectives within the Klein Ranch "16" State No. 1 include the Bone Spring, Queen and Delaware horizons. Due to the potential for up-hole completion, Adventure Exploration Partners, LLC requests that unorthodox location approval be granted for the Wolfcamp and all shallower formations spaced on 40 acres within the SE/4 SE/4 of Section 16.


The affected offset acreage is the SW/4 SE/4 of Section 16. The S/2 of Section 16 is all contained within State Lease No. VB-1345, which is leased by Adventure Exploration Partners, LLC. The working interest ownership within the SE/4 SE/4 and the SW/4 SE/4 of Section 16 is common; therefore, notice of this application to any other party is not required.

Also enclosed as Attachment 2 is a Form C-102 for the Klein Ranch "16" State No. 1, and a plat identified as Attachment 3 that shows all wells within the SE/4 of Section 16.

In summary, approval of the application will provide Adventure Exploration Partners, LLC the opportunity to recover Wolfcamp oil and gas reserves underlying the SE/4 SE/4 of Section 16, that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.




