Stephens & Johnson Operating Co. request administrative approval of a non-standard location for our Weatherly No. 11 well located at 1310 feet from the north line and 987 feet from the east line of Section 21, T21S, R37E in Lea County, New Mexico.

The well will be a producer in the Eunice Blinebry-Tubbs-Drinkard North Field (Pool Code 22900) which is an oil pool spaced on 40 acres. The non-standard location is needed since the well is located 10 feet from a unit line. The well is located 1310 feet from the north line and 987 feet from the west line of the Weatherly lease. The Weatherly lease consists of 240 acres located in the NW/4 and W/2 of NE/4 of Section 21, T21S R37E in Lea County, New Mexico and has common royalty and working interest ownerships.
